## SENATE BILL No. 333

---

DIGEST OF SB 333 (Updated February 18, 1999 2:23 pm - DI 98)

**Citations Affected:** IC 14-9.

**Synopsis:** Salaries of DNR law enforcement officers. Requires that law enforcement officers of the law enforcement division of the department of natural resources receive the same salaries as police employees of the state police department based upon years of service and rank held. Specifies that this requirement does not affect any rights or liabilities accrued or proceedings begun on or before June 30, 1999.

**Effective:** July 1, 1999.

PRINTING CODE. Amendments: Whenever an existing statute (or a section of the Indiana Constitution) is being amended, the text of the existing provision will appear in this style type, additions will appear in **this style type**, and deletions will appear in ~~this style type~~.

Additions: Whenever a new statutory provision is being enacted (or a new constitutional provision adopted), the text of the new provision will appear in **this style type**. Also, the word **NEW** will appear in that style type in the introductory clause of each SECTION that adds a new provision to the Indiana Code or the Indiana Constitution.

Conflict reconciliation: Text in a statute in *this style type* or ~~this style type~~ reconciles conflicts between statutes enacted by the 1998 General Assembly.

## SENATE BILL No. 333

A BILL FOR AN ACT to amend the Indiana Code concerning natural and cultural resources.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1 SECTION 1. IC 14-9-8-28 IS AMENDED TO READ AS  
2 FOLLOWS [EFFECTIVE JULY 1, 1999]: Sec. 28. (a) The natural  
3 resources commission shall categorize salaries of enforcement officers  
4 within each rank based upon the rank held and the number of years of  
5 service in the department through the tenth year. The salary ranges that  
6 the commission assigns to each rank shall be divided into a base salary  
7 and ten (10) increments above the base salary with:  
8 (1) the base salary in the rank paid to a person with less than one  
9 (1) year of service in the department; and  
10 (2) the highest salary in the rank paid to a person with at least ten  
11 (10) years of service in the department.  
12 (b) For purposes of creating the salary matrix prescribed by this  
13 section, the natural resources commission may not approve salary  
14 ranges for any rank that are less than the salary ranges effective for that  
15 rank on January 1, 1995.  
16 (c) The salary matrix prescribed by this section shall be reviewed  
17 and approved by the state budget agency before implementation.

1           (d) **The salaries for law enforcement officers of the law**  
2 **enforcement division of the department must be equal to the**  
3 **salaries of police employees of the state police department under**  
4 **IC 10-1-1-4.5, based upon years of service in the department and**  
5 **rank held.**  
6           (e) The money needed to fund the salaries resulting from the matrix  
7 prescribed by this section shall come from the appropriation from the  
8 professional and technical equity fund.  
9           (f) **The requirement of subsection (d) does not affect:**  
10           (1) **any rights or liabilities accrued; or**  
11           (2) **any proceedings begun;**  
12 **on or before June 30, 1999. Those rights, liabilities, and**  
13 **proceedings continue and shall be imposed and enforced under**  
14 **prior civil law and procedure as if the requirement of subsection**  
15 **(d) had not been enacted.**
