DIGEST OF SB 592 (Updated February 10, 1999 5:52 pm - DI 51)

**Citations Affected:** IC 34-24; IC 35-33.

**Synopsis:** Disposition of seized property. Requires property seized under the law concerning forfeiture of property used in violation of certain criminal statutes to be transferred, upon motion of a prosecuting attorney, to the appropriate federal authority for disposition, subject to all perfected liens and other security interests, under federal laws concerning customs duties and drug abuse prevention and control.

**Effective:** July 1, 1999.

## SENATE BILL No. 592



A BILL FOR AN ACT to amend the Indiana Code concerning civil and criminal law and procedure.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1 SECTION 1. IC 34-24-1-9 IS ADDED TO THE INDIANA CODE
- 2 A **NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY 1,**
- 3 **1999]: Sec. 9. Upon motion of a prosecuting attorney under**
- 4 **IC 35-33-5-5(i), property seized under this chapter must be**
- 5 **transferred, subject to the perfected liens or other security**
- 6 **interests of any person in the property, to the appropriate federal**
- 7 **authority for disposition under 19 U.S.C. 1616a or 21 U.S.C. 881(e).**
- 8 SECTION 2. IC 35-33-5-5 IS AMENDED TO READ AS
- 9 FOLLOWS [EFFECTIVE JULY 1, 1999]: Sec. 5. (a) All items of
- 10 property seized by any law enforcement agency as a result of an arrest,
- 11 search warrant, or warrantless search, shall be securely held by the law
- 12 enforcement agency under the order of the court trying the cause,
- 13 except as provided in this section.
- 14 (b) Evidence that consists of property obtained unlawfully from its
- 15 owner may be returned by the law enforcement agency to the owner
- 16 before trial, in accordance with IC 35-43-4-4(h).
- 17 (c) Following the final disposition of the cause at trial level or any

- 1 other final disposition **the following shall be done:**
- 2 (1) Property which may be lawfully possessed shall be returned
- 3 to its rightful owner, if known. If ownership is unknown, a
- 4 reasonable attempt shall be made by the law enforcement agency
- 5 holding the property to ascertain ownership of the property. After
- 6 ninety (90) days from the time:
- 7 (A) the rightful owner has been notified to take possession of
- 8 the property; or
- 9 (B) a reasonable effort has been made to ascertain ownership
- 10 of the property;
- 11 the law enforcement agency holding the property shall, at such
- 12 time as it is convenient, dispose of this property at a public
- 13 auction. The proceeds of this property shall be paid into the
- 14 county general fund.
- 15 (2) Property, the possession of which is unlawful, shall be
- 16 destroyed by the law enforcement agency holding it sixty (60)
- 17 days after final disposition of the cause.
- 18 (d) If any property described in subsection (c) was admitted into
- 19 evidence in the cause, the property shall be disposed of in accordance
- 20 with an order of the court trying the cause.
- 21 (e) For purposes of preserving the record of any conviction on
- 22 appeal, a photograph demonstrating the nature of the property, and an
- 23 adequate description of the property must be obtained before the
- 24 disposition of it. In the event of a retrial, the photograph and
- 25 description of the property shall be admissible into evidence in place
- 26 of the actual physical evidence. All other rules of law governing the
- 27 admissibility of evidence shall apply to the photographs.
- 28 (f) The law enforcement agency disposing of property in any manner
- 29 provided in subsections (b) and (c) of this section shall maintain
- 30 certified records of any such disposition. Disposition by destruction of
- 31 property shall be witnessed by two (2) persons who shall also attest to
- 32 the destruction.
- 33 (g) This section does not affect the procedure for the disposition of
- 34 firearms seized by a law enforcement agency.
- 35 (h) A law enforcement agency that disposes of property by auction
- 36 under this section shall permanently stamp or otherwise permanently
- 37 identify the property as property sold by the law enforcement agency.
- 38 (i) **Upon motion of the prosecuting attorney, the court shall**
- 39 **order property seized under IC 34-24-1 transferred, subject to the**
- 40 **perfected liens or other security interests of any person in the**
- 41 **property, to the appropriate federal authority for disposition under**
- 42 **19 U.S.C. 1616a or 21 U.S.C. 881(e).**
