11 program," and insert ",".

12 Page 15, line 5, delete "but" and insert "**the hospice employee**".

13 Page 15, line 5, after "services" insert "**or supplies**".

14 Page 15, line 7, delete "." and insert "**and documenting the**
15 **additional services or supplies that were provided in the hospice**
16 **program patient's medical record.**".
