

COMMITTEE REPORT

Mr. President: Pursuant to Joint Rule 20, your Committee on Rules and Legislative Procedure, to which was referred Engrossed House Bill 1104 because it conflicts with HEA 1299-1999 AND HEA 2022-1999 without properly recognizing the existence of HEA 1299-1999 AND HEA 2022-1999, has had Engrossed House Bill 1104 under consideration and begs leave to report back to the Senate with the recommendation that Engrossed House Bill 1104 be corrected as follows:

- 1 Page 2, line 3, before "IS" insert ", AS AMENDED BY
- 2 HEA 2022-1999,".
- 3 Page 2, line 4, delete the effective date "[EFFECTIVE JULY 1,
- 4 1999]" and insert the effective date "[EFFECTIVE JANUARY 1,
- 5 2000]".
- 6 Page 3, between lines 37 and 38, begin a new paragraph and insert:
- 7 "(j) All information relating to the delinquency or evasion of
- 8 commercial vehicle excise taxes payable to the bureau of motor
- 9 vehicles in Indiana must be disclosed to the bureau and may be
- 10 disclosed to another state, if the information is disclosed for the
- 11 purpose of the enforcement and collection of the taxes imposed by
- 12 IC 6-6-5.5.
- 13 (k) All information relating to the delinquency or evasion of
- 14 commercial vehicle excise taxes payable under the International
- 15 Registration Plan may be disclosed to another state, if the information
- 16 is disclosed for the purpose of the enforcement and collection of the
- 17 taxes imposed by IC 6-6-5.5."
- 18 Page 3, line 38, delete "(j)" and insert "(l)".
- 19 Page 4, line 2, delete "and".
- 20 Page 4, between lines 2 and 3, begin a new line block indented and
- 21 insert:
- 22 "(7) the commercial vehicle excise tax (IC 6-6-5.5); and".
- 23 Page 4, line 3, delete "(7)" and insert "(8)".
- 24 Page 4, line 4, delete "(k)" and insert "(m)".
- 25 Page 6, line 39, before "IS" insert ", AS AMENDED BY HEA 1299-

- 1 1999,".
- 2 Page 6, line 41, delete "small" and insert "farm".
- 3 Page 6, line 42, delete "table".
- 4 Page 6, line 42, delete ", to bottle wine,".
- 5 Page 7, line 1, delete "table".
- 6 Page 7, line 1, delete "small" and insert "farm".
- 7 Page 7, line 3, delete "table".
- 8 Page 7, line 4, delete "table".
- 9 Page 7, line 7, delete "table".
- 10 Page 14, between lines 17 and 18, begin a new paragraph and insert:
- 11 "SECTION 16. [EFFECTIVE JULY 1, 1999] (a) **The name and**
- 12 **business address of retail merchants within each county that sell**
- 13 **tobacco products may be released to the division of mental health**
- 14 **and the alcoholic beverage commission solely for the purpose of the**
- 15 **list prepared under IC 6-2.5-6-14.**
- 16 (b) **This SECTION expires January 1, 2000.**".
- 17 Renumber all SECTIONS consecutively.
