MR. PRESIDENT:

The Senate Committee on Health and Provider Services, to which was referred House Bill No. 1108, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be **AMENDED** as follows:

- 1 Page 1, line 2, delete the effective date "[EFFECTIVE JULY, 1,
- 2 1999]" and insert "[EFFECTIVE JANUARY 1, 2000]".
- 3 Page 1, line 10, reset in roman "However,".
- 4 Page 1, line 11, delete "The" and insert "the".
- 5 Page 1, line 11, reset in roman "does not include".
- 6 Page 1, line 11, delete "includes".
- 7 Page 2, line 39, delete the effective date "[EFFECTIVE JULY, 1,
- 8 1999]" and insert "[EFFECTIVE JANUARY 1, 2000]".
- 9 Page 3, line 8, reset in roman "However,".
- 10 Page 3, line 8, delete "The" and insert "the".
- 11 Page 3, line 9, reset in roman "does not include".
- 12 Page 3, line 9, delete "includes".
- 13 Page 3, line 14, strike "June 30, 1998;" and insert "**December 31,**
- 14 **1999;**".
- 15 Page 3, line 18, strike "Except for an employee benefit program
- 16 under IC 5-10-8, an".
- 17 Page 3, strike lines 19 through 20.
- 18 Page 3, line 21, strike "(2)".

- 1 Page 3, line 27, strike "(3)".
- 2 Page 3, line 27, before "A" insert "(2)".
- 3 Page 3, between lines 37 and 38, begin a new paragraph and insert:
- 4 "(f) **The benefits delivered under this section may be delivered**
- 5 **under a managed care system.**".
- 6 Page 4, line 5, delete "applicant" and insert "**insurer or a health**
- 7 **maintenance organization that applies**".
- 8 Page 4, line 9, delete "applicant's" and insert "**insurer's or health**
- 9 **maintenance organization's**".
- 10 Page 4, line 15, delete the effective date "[EFFECTIVE JULY, 1,
- 11 1999]" and insert "[EFFECTIVE JANUARY 1, 2000]".
- 12 Page 4, line 26, reset in roman "However,".
- 13 Page 4, line 26, delete "The" and insert "the".
- 14 Page 4, line 26, reset in roman "does not include".
- 15 Page 4, line 27, delete "includes".
- 16 Page 4, line 31, strike "June 30, 1998;" and insert "**December 31,**
- 17 **1999;**".
- 18 Page 4, line 34, strike "the following:".
- 19 Page 4, strike lines 35 through 37.
- 20 Page 5, line 2, delete "(2) A" and insert "a".
- (Reference is to HB 1108 as reprinted February 16, 1999.)
