

COMMITTEE REPORT

MR. PRESIDENT:

The Senate Committee on Health and Provider Services, to which was referred Senate Bill No. 113, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:

- 1 Page 1, between the enacting clause and line 1, begin a new
- 2 paragraph and insert:
- 3 "SECTION 1. IC 16-18-2-287.7 IS ADDED TO THE INDIANA
- 4 CODE AS A NEW SECTION TO READ AS FOLLOWS
- 5 [EFFECTIVE JULY 1, 1999]: **Sec. 287.7. "Post-organ transplant**
- 6 **program", for purposes of IC 16-41-19.5, has the meaning set forth**
- 7 **in IC 16-41-19.5-1."**
- 8 Page 1, line 5, delete "Post-Kidney" and insert "**Post-Organ**".
- 9 Page 1, between lines 5 and 6, begin a new paragraph and insert:
- 10 "**Sec. 1. As used in this chapter, "post-organ transplant**
- 11 **program" refers to a program established by the state department**
- 12 **to pay recipients eligible under this chapter for costs of**
- 13 **immunosuppressive drugs prescribed exclusively for the**
- 14 **maintenance of individuals who undergo the transplant of an**
- 15 **internal organ, including a heart, lung, liver, or kidney, if the costs**
- 16 **of the drugs are not reimbursed from other sources."**
- 17 Page 1, line 6, delete "1" and insert "2".
- 18 Page 1, line 6, after "a" insert "**post-organ transplant**".
- 19 Page 1, line 6, delete "to pay" and insert ".".
- 20 Page 1, delete lines 7 through 10.

- 1 Page 1, line 11, delete "2" and insert "3".
- 2 Page 1, line 12, delete "post-kidney" and insert "**post-organ**".
- 3 Page 1, line 16, after "hundred" insert "**fifty**".
- 4 Page 1, line 16, delete "(200%)" and insert "**(250%)**".
