- 19 Page 8, line 19, delete "A" and insert "**Except as provided in**
20 **subsection (f), a**".
- 21 Page 8, line 23, delete "The" and insert "**Except as provided in**
22 **subsection (f), the**".
- 23 Page 8, line 31, delete "The" and insert "**Except as provided in**
24 **subsection (f), the**".
- 25 Page 8, line 36, delete "The" and insert "**Except as provided in**
26 **subsection (f), the**".
- 27 Page 8, between lines 38 and 39, begin a new paragraph and insert:

1 **"(f) In the case of coverage that is not employer based, the**
2 **health maintenance organization must offer to provide the**
3 **coverage described in subsections (b) through (e)."**
