

COMMITTEE REPORT

MR. PRESIDENT:

The Senate Committee on Corrections, Criminal and Civil Procedures, to which was referred House Bill No. 1522, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:

- 1 Page 1, between lines 4 and 5, begin a new paragraph and insert:
- 2 **"Sec. 1. This chapter does not apply to the following:**
- 3 **(1) A cemetery owner (as defined in IC 23-14-33-8) in the**
- 4 **course of performing a legitimate function under IC 23-14 in**
- 5 **relation to the owner's cemetery (as defined in IC 23-14-33-7).**
- 6 **(2) The owner of a grave memorial who, for the purpose of**
- 7 **replacing a grave memorial with a different grave memorial,**
- 8 **transfers ownership of the grave memorial to a cemetery,**
- 9 **cemetery owner, or grave memorial provider."**
- 10 Page 1, line 5, delete "1." and insert "2."
- 11 Page 1, line 8, delete "2." and insert "3."
- 12 Page 2, between lines 4 and 5, begin a new paragraph and insert:
- 13 **"(c) A county recorder is:**
- 14 **(1) not required to obtain special recording equipment for the**
- 15 **purpose of recording the information listed in subsection (a);**
- 16 **and**
- 17 **(2) required to record only the information listed in**
- 18 **subsection (a) that the recorder's current recording**
- 19 **equipment can accommodate.**
- 20 **(d) The state board of accounts shall prescribe a form for**

- 1 **recording the information listed in subsection (a). The form shall**
 - 2 **be available to the public at each local health department office."**
 - 3 Page 2, line 5, delete "3." and insert "4."
 - 4 Page 2, delete lines 12 through 17.
 - 5 Page 4, line 11, after "grounds" delete ":".
 - 6 Page 4, delete line 12.
 - 7 Page 4, line 13, delete "(B)".
 - 8 Page 4, line 13, delete "in common with:".
 - 9 Page 4, run in lines 11 and 13.
 - 10 Page 4, line 14, before "a" insert "**by**".
 - 11 Page 4, line 19, delete "two".
 - 12 Page 4, delete lines 20 through 21.
 - 13 Page 4, line 22, delete "is at least".
 - 14 Page 4, delete lines 23 through 42.
 - 15 Delete page 5.
