SENATE CONCURRENT RESOLUTION

A CONCURRENT RESOLUTION congratulating Joseph J. Andrew upon his selection as the Chair of the Democratic National Committee.

Whereas, on Saturday, January 23, 1999, Joe Andrew, who has served as the Indiana Democratic State Central Committee Chair since 1995, was named the new Chair of the Democratic National Committee;

Whereas, Mr. Andrew is a 1978 graduate of Wayne High School in Fort Wayne, Indiana; thereafter, he graduated magna cum laude from Yale University in 1982, and received a Doctorate in Jurisprudence from Yale Law School in 1985;

Whereas, Joe has worked diligently for the Democratic Party in Indiana for more than twenty years, beginning as a volunteer for Congressman Ed Roush and Fort Wayne Mayor Win Moses; later serving as the Manager of Jack Wickes' race for the U.S. Senate and the Chair of Jeff Modisett's campaign for Marion County Prosecutor;
