DIGEST OF SB 373 (Updated February 16, 2000 11:07 AM - DI 22)

Citations Affected: IC 21-9; noncode.

Synopsis: Save Indiana program. Repeals the save Indiana program of the Indiana education savings authority and makes conforming changes. Extends from July 1, 2000, to July 1, 2001, the expiration date of a noncode provision that requires the treasurer of state, the board for depositories, the commission for higher education, and the state student assistance commission to provide certain administrative and financial support to the Indiana education savings authority.

Effective: June 30, 2000; July 1, 2000.

ENGROSSED SENATE BILL No. 373

A BILL FOR AN ACT to amend the Indiana Code concerning education finance.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 21-9-1-1 IS AMENDED TO READ AS FOLLOWS
2 [EFFECTIVE JULY 1, 2000]: Sec. 1. The following are the purposes

4 (1) To encourage elementary and secondary students in Indiana
5 to achieve high standards of performance and establish lifelong
6 habits of fiscal responsibility through savings.
7 (2) To encourage education and the means of education.
8 (3) To encourage attendance at higher education institutions.
9 (4) To provide families additional means of striving for higher
10 education through the ~~save Indiana program and the~~ Indiana
11 family college savings programs that may be established under
12 this article.
13 (5) To help provide the benefits of higher education to the people
14 of Indiana.
15 (6) To promote the economic development of the state by creating
16 opportunities for a more highly educated workforce.
17 (7) To increase employment opportunities in Indiana.
