MR. SPEAKER:

I move that House Bill 1235 be amended to read as follows:

- 1 Page 1, between the enacting clause and line 1, begin a new
- 2 paragraph and insert:
- 3 "SECTION 1. IC 6-1.1-18.5-21 IS ADDED TO THE INDIANA
- 4 CODE AS A NEW SECTION TO READ AS FOLLOWS
- 5 [EFFECTIVE JULY 1, 2000]: **Sec. 21. (a) The ad valorem property**
- 6 **tax levy limits imposed by section 3 of this chapter do not apply to**
- 7 **ad valorem property taxes imposed by a county for a property**
- 8 **reassessment fund under IC 6-1.1-4-27.**
- 9 **(b) For purposes of computing the ad valorem property tax levy**
- 10 **limits imposed on a county by section 3 of this chapter, a county's**
- 11 **ad valorem property tax levy for a calendar year does not include**
- 12 **that part of its levy that is imposed under IC 6-1.1-4-27 for a**
- 13 **cumulative building fund."**
- 14 Page 3, between lines 28 and 29, begin a new paragraph and insert:
- 15 "SECTION 2. [EFFECTIVE JULY 1, 2000] **(a) The maximum**
- 16 **permissible ad valorem property tax levy for a county under**
- 17 **IC 6-1.1-18.5 shall be reduced for 2001 by the property taxes**
- 18 **imposed for the county's property reassessment fund for 2000 to**
- 19 **reflect the removal of the property reassessment fund from the**
- 20 **application of IC 6-1.1-18.5, as provided in IC 6-1.1-18.5-21, as**
- 21 **added by this act.**
- 22 **(b) For purposes of determining a county's maximum**
- 23 **permissible ad valorem property tax levy under IC 6-1.1-18.5-3 for**
- 24 **property taxes payable in 2001 and thereafter, the county's**

1 **maximum permissible ad valorem property tax levy is the levy**
2 **after the adjustment made under this SECTION."**

3 Page 3, between lines 40 and 41, begin a new paragraph and insert:
4 "SECTION 3. [EFFECTIVE JULY 1, 2000] **IC 6-1.1-18.5-21, as**
5 **added by this act, applies to property taxes first due and payable**
6 **after December 31, 2000."**

7 Renumber all SECTIONS consecutively.
