MR. SPEAKER:

I move that House Bill 1374 be amended to read as follows:

- 1 Page 5, between lines 22 and 23, begin a new paragraph and insert:
- 2 "SECTION 7. IC 6-1.1-18.5-21 IS ADDED TO THE INDIANA
- 3 CODE AS A NEW SECTION TO READ AS FOLLOWS
- 4 [EFFECTIVE JULY 1, 2000]: **Sec. 21. (a) The ad valorem property**
- 5 **tax levy limits imposed by section 3 of this chapter do not apply to**
- 6 **ad valorem property taxes imposed by a county for a property**
- 7 **reassessment fund under IC 6-1.1-4-27.**
- 8 **(b) For purposes of computing the ad valorem property tax levy**
- 9 **limits imposed on a county by section 3 of this chapter, a county's**
- 10 **ad valorem property tax levy for a calendar year does not include**
- 11 **that part of its levy that is imposed under IC 6-1.1-4-27 for a**
- 12 **cumulative building fund."**
- 13 Page 71, between lines 4 and 5, begin a new paragraph and insert:
- 14 "SECTION 94. [EFFECTIVE JULY 1, 2000] **(a) The maximum**
- 15 **permissible ad valorem property tax levy for a county under**
- 16 **IC 6-1.1-18.5 shall be reduced for 2001 by the property taxes**
- 17 **imposed for the county's property reassessment fund for 2000 to**
- 18 **reflect the removal of the property reassessment fund from the**
- 19 **application of IC 6-1.1-18.5, as provided in IC 6-1.1-18.5-21, as**
- 20 **added by this act.**
- 21 **(b) For purposes of determining a county's maximum**
- 22 **permissible ad valorem property tax levy under IC 6-1.1-18.5-3 for**
- 23 **property taxes payable in 2001 and thereafter, the county's**
- 24 **maximum permissible ad valorem property tax levy is the levy**

- 1 **after the adjustment made under this SECTION."**
- 2 Page 71, between lines 18 and 19, begin a new paragraph and insert:
- 3 "SECTION 99. [EFFECTIVE JULY 1, 2000] **IC 6-1.1-18.5-21, as**
- 4 **added by this act, applies to property taxes first due and payable**
- 5 **after December 31, 2000."**
- 6 Renumber all SECTIONS consecutively.
