- 14 **Sec. 8. The commission shall charge a fee of ten dollars (\$10) for**
- 15 **an employee who:**
- 16 **(1) has not been issued a permit under IC 7.1-3-18-9; and**
- 17 **(2) is enrolled in a training program administered by an**
- 18 **enforcement officer training unit.**
- 19 **The fee charged under this section must be deposited in the**
- 20 **responsible retail permittee fund established by section 7 of this**
- 21 **chapter."**
