2           Page 4, between lines 39 and 40, begin a new paragraph and

5 **shall not provide medically accurate information under this section**  
6 **that in any way jeopardizes federal or state funding for abstinence**  
7 **education."**  
8           Page 5, line 7, after "accuracy." insert "**The state department of**  
9 **health and each public school shall not provide medically accurate**  
10 **information under this section that in any way jeopardizes federal**  
11 **or state funding for abstinence education."**  
12           Page 5, line 29, after "requires medical accuracy" insert "**The state**  
13 **department of health and the state board of education shall not**  
14 **provide medically accurate information under this section that in**  
15 **any way jeopardizes federal or state funding for abstinence**  
16 **education."**
