DIGEST OF HB 1053 (Updated January 19, 2000 10:47 AM - DI 92)

**Citations Affected:** IC 9-21.

**Synopsis:** Passengers in truck cargo areas. Makes it a Class C infraction to operate a truck while a person less than 18 years of age is in the open bed of the truck. Exceptions are made for parades, certain farm operations, and certain trucks equipped with safety belts.

**Effective:** July 1, 2000.

## HOUSE BILL No. 1053

---

A BILL FOR AN ACT to amend the Indiana Code concerning education.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1 SECTION 1. IC 9-21-8-55 IS ADDED TO THE INDIANA CODE  
2 AS A **NEW SECTION** TO READ AS FOLLOWS [EFFECTIVE JULY  
3 1, 2000]: **Sec. 55. (a) An individual may not operate a truck on a  
4 public highway while another individual, who is less than eighteen  
5 (18) years of age, is in the open bed of the truck.**  
6 **(b) Subsection (a) does not apply to an individual operating a  
7 truck:**  
8 **(1) in a parade;**  
9 **(2) in connection with an agricultural activity; or**  
10 **(3) in which all persons less than eighteen (18) years of age  
11 who are in the open bed of the truck are:**  
12 **(A) in attached seats; and**  
13 **(B) secured by safety belts.**  
14 **(c) The operator of a truck transporting passengers in the open  
15 bed of a truck must have a tailgate on the truck, and the tailgate  
16 must be in an upright and secured position.**
