DIGEST OF HB 1058 (Updated January 26, 2000 1:03 PM - DI 22)

Citations Affected: IC 20-8.1.

Synopsis: High school student transcripts. Requires a school corporation to record or include immunization information on a student's high school transcript as taken from the immunization record the student's school is required to keep under current law. Allows school corporations to include information on high school transcripts that is in addition to the minimum statutory requirements.

Effective: July 1, 2000.

11 **the student's school keeps under IC 20-8.1-7-9.**
12 (b) A school corporation may include information on a student's
13 high school transcript that is in addition to the requirements of
14 subsection (a).
