- 1 Page 2, line 14, reset in roman "petition and".
- 2 Page 2, line 15, reset in roman "remonstrance process against".
- 3 Page 2, line 15, delete "referendum on".
- 4 Page 2, line 19, reset in roman "application of".
- 5 Page 2, line 20, reset in roman "a petition and remonstrance
- 6 process".
- 7 Page 2, line 20, delete "referendum".
- 8 Page 2, line 21, strike "lesser of:" and insert "**following:**".
- 9 Page 2, line 22, after "(250)" insert "**If the population of the**
- 10 **political subdivision is less than fifty thousand (50,000),**".
- 11 Page 2, strike lines 24 through 25, begin a new line double block
- 12 indented and insert:
- 13 "**(B) If the population of the political subdivision is at least**
- 14 **fifty thousand (50,000), but less than one hundred thousand**

- 1 **(100,000), six hundred (600) owners of real property within**
- 2 **the political subdivision.**
- 3 **(C) If the population of the political subdivision is at least one**
- 4 **hundred thousand (100,000), but less than two hundred**
- 5 **thousand (200,000), seven hundred (700) owners of real**
- 6 **property within the political subdivision.**
- 7 **(D) If the population of the political subdivision is at least two**
- 8 **hundred thousand (200,000), but less than three hundred**
- 9 **thousand (300,000), eight hundred (800) owners of real**
- 10 **property within the political subdivision.**
- 11 **(E) If the population of the political subdivision is at least**
- 12 **three hundred thousand (300,000), but less than four hundred**
- 13 **thousand (400,000), nine hundred (900) owners of real**
- 14 **property within the political subdivision.**
- 15 **(F) If the population of the political subdivision is at least four**
- 16 **hundred thousand, nine hundred ninety-nine (999) owners of**
- 17 **real property within the political subdivision."**
- 18 Page 2, line 42, reset in roman "petition and remonstrance process".
- 19 Page 2, line 42, delete "referendum".
- 20 Page 3, line 3, reset in roman "petition and remonstrance process".
- 21 Page 3, line 4, delete "referendum".
- 22 Page 3, delete lines 8 through 42.
- 23 Delete pages 4 through 7.
- 24 Page 8, delete lines 1 through 5, begin a new paragraph and insert:
- 25 "SECTION 4. [EFFECTIVE UPON PASSAGE] **(a)**
- 26 **IC 6-1.1-20-3.1, as amended by this act, does."**
- 27 Page 8, line 10, delete ", IC 6-1.1-20-3.2, and IC 6-1.1-20-9,".
- 28 Page 8, line 11, delete "apply" and insert "**applies**".
- 29 ReNUMBER all SECTIONS consecutively.
- 30 (Reference is to HB 1235 as introduced.)
