A CONCURRENT RESOLUTION congratulating the Eastern Hancock livestock judging team for being named national champions at the North American International Livestock Exposition in Louisville, Kentucky.

Whereas, Participation on a livestock judging team gives young people the opportunity to learn the skill of livestock evaluation and to express their opinions through oral presentation;

Whereas, Livestock judging team members learn to apply scientific principles of animal growth, evaluation, and selection to different types of animals and to analyze breeding and market classes of beef cattle, swine, and sheep;

Whereas, Livestock judging competitions are held throughout the United States;

Whereas, These competitions challenge the team members and determine what knowledge and communication skills have been obtained;

Whereas, Tony Holliday, Wesley Broadwater, Jake Wilson, and Luke McDonnell make up the Eastern Hancock livestock judging team;

Whereas, Tony Holliday and Wesley Broadwater are seniors at Eastern Hancock High School; Jake Wilson is a graduate of Eastern Hancock High School; and Luke McDonnell is a graduate of Blue River High School;



Whereas, The Eastern Hancock livestock judging team represented Indiana recently at the North American International Livestock Exposition in Louisville, Kentucky;

Whereas, Many states send an all-star team to the competition, but Indiana sends the team that won its state meet;

Whereas, These fine young men represented Indiana admirably and brought home a first place finish;

Whereas, The Eastern Hancock team is only the third Indiana team to win the championship in the 80 year history of the competition;

Whereas, This first place finish qualifies the Eastern Hancock team to represent the United States in European competition this summer; and

Whereas, When it comes to preparing future leaders for agriculture and the livestock industry, few forms of educational training can compare with the experience that these four young men have gained from participating on the judging team: Therefore,
