A CONCURRENT RESOLUTION honoring the 1999 IHSAA State Champion North Central High School Women's Soccer Team.

Whereas, The North Central High School Women's Soccer Team's 1999 IHSAA State Soccer Championship was the pinnacle of success after winning Semi-state, Regional and Sectional championships and the Marion County Championship;

Whereas, The North Central High School Women's Soccer Team was recognized nationally, receiving the National Federation of High Schools/Galyan's Cinderella Award, and being ranked 21st in the nation by adidas/NSCAA/USA Today;

Whereas, The season record of 21 wins/1 loss/3 ties was outstanding, as the team scored 87 goals against their opponents, only allowed 14 goals to be scored against them, and totally shut-out competitors an amazing 13 times;

Whereas, The athletic prowess of the North Central High School Women's Soccer Team is matched by their excellent academic achievement, as seven members of the team have a grade point average of 4.0 or above, 16 players have a grade point average of 3.5 or higher, and the team grade point average is 3.4 on a 4.0 scale;

Whereas, It is clear that the North Central High School Women's Soccer Team players, coach, assistant coaches, manager and trainers have a tremendous amount of talent and dedication to the pursuit of excellence which enabled them to reap such high honor, well-deserved, during the 1999 season;

Whereas, The North Central High School Women's Soccer Team players, and coaching and training staff, have set a record of athletic and academic achievement that sets a high standard for Indiana women's athletics;
