
SENATE BILL No. 89

DIGEST OF INTRODUCED BILL

Citations Affected: IC 20-8.1.

Synopsis: Indianapolis Public Schools vouchers. Establishes a voucher program for students having legal settlement in the area served by Indianapolis Public Schools (IPS). Allows a student's parent to request a voucher for the student to enroll in a different IPS school from the one where the student is assigned or an accredited nonpublic school located within the territory served by IPS. Allows the school that the parent selects to determine whether to accept the student for enrollment under the voucher program. Provides vouchers for attending nonpublic schools in an amount equal to 100% of the state aid per ADM established for IPS. Requires the parent to pay all other costs of attending the nonpublic school and to provide transportation. Prohibits enrollment of a voucher student to negate compliance with certain court orders. Provides for administration of the voucher program by the department of education.

Effective: July 1, 2000.

Be it enacted by the General Assembly of the State of Indiana:

2 **Chapter 14. School Voucher Program**

3 **Sec. 1. As used in this chapter, "program" refers to the school**
 4 **voucher program established by this chapter.**

5 **Sec. 2. As used in this chapter, "voucher" refers to a voucher**
 6 **under the school voucher program.**

7 **Sec. 3. The school voucher program is established.**

8 **Sec. 4. On a date the department specifies that falls before the**
 9 **beginning of a school year, the department shall grant initial and**
 10 **renewal vouchers under this chapter.**

11 **Sec. 5. The department shall grant an initial voucher to a**
 12 **student who meets the following requirements:**

13 (1) **The student has legal settlement in a school corporation**
 14 **that:**

15 (A) **is located in whole or in part in the most populous**
 16 **township in a county having a population of more than**
 17 **seven hundred thousand (700,000); and**

18 (B) **serves the largest geographical territory of any school**
 19 **corporation in the township.**

20 (2) **The student's parent requests a voucher for the student.**

21 (3) **The student's parent selects a school for the student to**
 22 **attend under the voucher program that is:**

23 (A) **a public school located in the school corporation where**
 24 **the student has legal settlement but is a different school**
 25 **from the school that the school corporation has assigned**
 26 **the student to attend; or**

27 (B) **an accredited nonpublic school located within the same**
 28 **geographic territory as the territory of the school**
 29 **corporation where the student has legal settlement.**

30 (4) **The parent does not wish to enroll a student in a school**
 31 **under the voucher program primarily for athletic reasons.**

32 (5) **Except as provided in section 13(b) of this chapter, the**
 33 **principal of the school and the superintendent of the school**
 34 **corporation (or equivalent authorities for a nonpublic school)**
 35 **jointly consent to enroll the student in the school.**

36 **Sec. 6. The department shall grant a renewal voucher to a**
 37 **student who:**

38 (1) **previously received a voucher in any year; and**

39 (2) **meets the requirements of section 5 of this chapter.**

40 **Sec. 7. Not later than June 30 before the beginning of a school**
 41 **year for which a parent seeks a voucher, the student's parent shall**
 42 **notify the superintendent of the school corporation (or equivalent**

1 authority for a nonpublic school) that the parent wishes to enroll
2 the student in the school under the voucher program.

3 **Sec. 8. (a) If a parent seeks enrollment of a student in a public**
4 **school under the voucher program, the superintendent of the**
5 **school corporation:**

- 6 (1) is not required to enroll the student; and
7 (2) may not enroll the student if enrollment will cause the
8 school corporation to be out of compliance with a court order,
9 including a court order described in IC 20-8.1-6.5-1.

10 (b) A superintendent may not refuse to enroll a student in
11 violation of IC 20-8.1-2.

12 **Sec. 9. Not later than fourteen (14) days before the first day of**
13 **the school year, the superintendent (or equivalent authority for a**
14 **nonpublic school) who receives a request under section 7 of this**
15 **chapter shall notify the parent who makes the request of the**
16 **decision concerning enrollment of the student in the school.**

17 **Sec. 10. The following apply when a student uses a voucher to**
18 **attend a public school:**

- 19 (1) There is no monetary voucher award.
20 (2) There is no change in:
21 (A) the ADM of the school corporation; or
22 (B) state assistance to the school corporation.
23 (3) The school corporation is not required to provide
24 transportation for the student.

25 **Sec. 11. The following apply when a student uses a voucher to**
26 **attend an accredited nonpublic school:**

- 27 (1) The amount of the voucher award is one hundred percent
28 (100%) of the state aid per ADM provided under IC 21-3 to
29 the school corporation where the student has legal settlement.
30 (2) The student remains in the ADM of the school corporation
31 where the student has legal settlement.
32 (3) The department shall do the following:
33 (A) On behalf of the parent, pay the amount of the voucher
34 to the school that the student attends.
35 (B) Deduct the amount of the voucher from the
36 distribution of state aid to the school corporation where
37 the student has legal settlement.
38 (4) The parent of the student is responsible for all costs of the
39 student to attend the school that exceed the amount of the
40 voucher.
41 (5) The school corporation where the student has legal
42 settlement is not responsible for providing transportation for

the student.
Sec. 12. Except as provided in section 13(b) of this chapter, at the end of each school year the superintendent of the school corporation and the principal of the school that the student attends under the voucher program (or equivalent authorities for a nonpublic school) shall jointly:

- (1) determine whether to enroll the student for the following school year; and
- (2) inform the department of the decision.

Sec. 13. (a) The governing body of a school corporation described in section 5(1) may adopt a policy that sets guidelines to be used in determining whether:

- (1) to accept a student for enrollment under the program; and
- (2) to continue a student's enrollment under the program.

(b) Notwithstanding sections 5(5) and 12 of this chapter, a policy adopted under this section may provide that the governing body makes a determination of whether to enroll a student or continue a student's enrollment under the program.

Sec. 14. The department shall establish procedures for the administration of this chapter.

Sec. 15. The department may adopt rules under IC 4-22-2 to implement and administer the program.

SECTION 5. [EFFECTIVE JULY 1, 2000] (a) As used in this SECTION, "department" has the meaning set forth in IC 20-8.1-1-17.

(b) As used in this SECTION, "school year" has the meaning set forth in IC 20-10.1-2-1.

(c) The department shall grant vouchers under IC 20-8.1-14, as added by this act, beginning with the 2001-2002 school year.

(d) This SECTION expires July 1, 2003.
