DIGEST OF INTRODUCED BILL

Citations Affected: IC 15-1-1.5; IC 15-1.5-10.5-12.

Synopsis: State fair advisory committee and center for agricultural science and heritage. Requires the state fair advisory committee to oversee the activities and affairs of the trustees of the center for agricultural science and heritage. Requires the trustees of the center for agricultural science and heritage to report to the state fair advisory committee, at the state fair advisory committee's first meeting each year, the previous year's activities of the center for agricultural science and heritage.

Effective: Upon passage.

HOUSE BILL No. 1155

A BILL FOR AN ACT to amend the Indiana Code concerning agriculture and animals.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 15-1-1.5-0.5 IS ADDED TO THE INDIANA
2 CODE AS A **NEW** SECTION TO READ AS FOLLOWS
3 [EFFECTIVE UPON PASSAGE]: **Sec. 0.5. As used in this chapter,**
4 **"barn" refers to the center for agricultural science and heritage**
5 **established by IC 15-1.5-10.5-3.**

6 SECTION 2. IC 15-1-1.5-8 IS AMENDED TO READ AS
7 FOLLOWS [EFFECTIVE UPON PASSAGE]: Sec. 8. The committee
8 shall do the following:

- 9 (1) Serve as liaison between the commission, **the board of**
10 **trustees of the barn**, the board, and the general assembly.
11 (2) Review policies affecting the activities of the commission, **the**
12 **barn**, the state fair, the facilities at the fairgrounds, and the
13 property owned by the commission.
14 (3) Provide long range guidance for the commission, **the board**
15 **of trustees of the barn**, and the board.
16 (4) Review annually the commission's, **the board of trustees of**

1 **the barn's**, and the board's budgets and other accounts and report
2 financial conditions to the legislative council. Further advise the
3 budget committee regarding appropriations and other financial
4 matters concerning the commission, **the board of trustees of the**
5 **barn**, and the board.

6 (5) Propose, review, and make recommendations concerning
7 legislation affecting the commission, **the barn**, and the board.

8 SECTION 3. IC 15-1-1.5-9 IS AMENDED TO READ AS
9 FOLLOWS [EFFECTIVE UPON PASSAGE]: Sec. 9. (a) The
10 commission or board shall provide any information relating to the
11 operation of the commission, **the board of trustees of the barn**, or
12 board requested by the committee.

13 (b) The legislative services agency shall provide staff for the
14 committee.

15 SECTION 4. IC 15-1.5-10.5-12 IS ADDED TO THE INDIANA
16 CODE AS A NEW SECTION TO READ AS FOLLOWS
17 [EFFECTIVE UPON PASSAGE]: **Sec. 12. At the first meeting each**
18 **year of the state fair advisory committee established by**
19 **IC 15-1-1.5-4, the trustees shall report the following:**

- 20 (1) **The activities of the barn during the previous calendar**
- 21 **year.**
- 22 (2) **The financial condition of the barn for the barn's most**
- 23 **recently completed fiscal year.**
- 24 (3) **The board of trustees' plans for the barn for the current**
- 25 **calendar year.**

26 SECTION 5. **An emergency is declared for this act.**
