DIGEST OF INTRODUCED BILL

Citations Affected: IC 34-6-2; IC 34-30-11.2.

Synopsis: Civil immunity for volunteers. Grants immunity from liability for civil damages resulting from a negligent act or omission of a volunteer other than an act or omission related to the operation of a motor vehicle. Limits the maximum liability for the operation of a motor vehicle by a volunteer to the limits of the insurance coverage maintained by or for the volunteer.

Effective: July 1, 2000.

HOUSE BILL No. 1404



A BILL FOR AN ACT to amend the Indiana Code concerning civil law and procedure.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 34-6-2-49 IS AMENDED TO READ AS
2 FOLLOWS [EFFECTIVE JULY 1, 2000]: Sec. 49. "Governmental
3 entity":

4 (1) for purposes of IC 34-13-2, IC 34-13-3, and IC 34-13-4,
5 means the state or a political subdivision of the state; **and**

6 (2) **for the purposes of IC 34-30-11.2, means an entity that**
7 **exercises any of the governmental powers of the state, a**
8 **political subdivision (as defined in IC 36-1-2-13), or another**
9 **local governmental entity. The term includes a task force, an**
10 **elected official, and an association of governmental officials or**
11 **entities.**

12 SECTION 2. IC 34-6-2-88.4 IS ADDED TO THE INDIANA CODE
13 AS A **NEW SECTION** TO READ AS FOLLOWS [EFFECTIVE JULY
14 1, 2000]: **Sec. 88.4. As used in this chapter, "nonprofit corporation"**
15 **means a corporation that is exempt from federal taxation under**
16 **Section 501(a) of the Internal Revenue Code (26 U.S.C. 501(a), as**
17 **amended).**



1 SECTION 3. IC 34-6-2-88.5 IS ADDED TO THE INDIANA CODE
2 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
3 1, 2000]: **Sec. 88.5. As used in this chapter, "nonprofit
4 organization" means an organization that is exempt from federal
5 taxation under Section 501(c) of the Internal Revenue Code (26
6 U.S.C. 501(c), as amended).**

7 SECTION 4. IC 34-6-2-150 IS AMENDED TO READ AS
8 FOLLOWS [EFFECTIVE JULY 1, 2000]: Sec. 150. "Volunteer":

9 (1) for purposes of IC 34-30-19, means an individual who,
10 without compensation, engages in or provides other personal
11 services for a sports or leisure activity such as baseball,
12 basketball, football, soccer, hockey, volleyball, cheerleading, or
13 other similar sports or leisure activities involving children who
14 are less than sixteen (16) years of age; **and**

15 (2) **for the purposes of IC 34-30-11.2, means a person
16 performing services for a nonprofit organization, a nonprofit
17 corporation, a hospital, or a governmental entity without
18 compensation other than reimbursement for the actual
19 expenses of the person. The term includes a volunteer serving
20 as a director, an officer, a trustee, or a direct service
21 volunteer.**

22 SECTION 5. IC 34-30-11.2 IS ADDED TO THE INDIANA CODE
23 AS A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE
24 JULY 1, 2000]:

25 **Chapter 11.2. Immunity From Civil Liability for Volunteers**

26 **Sec. 1. Except as provided by this chapter, a volunteer is not
27 liable for civil damages as a result of an act or omission of the
28 volunteer if:**

29 (1) **the volunteer was acting in good faith and within the scope
30 of the volunteer's official functions and duties for a nonprofit
31 organization, nonprofit corporation, hospital, or
32 governmental entity; and**

33 (2) **the damage or injury was not caused by willful or wanton
34 misconduct by the volunteer.**

35 **Sec. 2. This chapter does not exempt a hospital from liability
36 that the hospital would otherwise have for the negligent act of a
37 volunteer.**

38 **Sec. 3. This chapter does not grant immunity to a volunteer for
39 an act or omission involving the operation of a motor vehicle.
40 However, the liability of the volunteer does not exceed the limits of
41 the applicable insurance coverage maintained by or on behalf of
42 the volunteer with respect to the negligent operation of a motor
43 vehicle in the circumstances.**

44 SECTION 6. [EFFECTIVE JULY 1, 2000] **IC 34-30-11.2, as added**
