SENATE BILL No. 11

DIGEST OF SB 11 (Updated January 20, 2000 2:38 PM - DI 71)

Citations Affected: IC 20-8.1; noncode.

Synopsis: Public school scholarship program. Establishes a public elementary and secondary school scholarship program. Allows the parent of a public school student to request a scholarship for the student to enroll in: (1) a different public school in the student's base school corporation; or (2) a public school in a different school corporation. Provides an allocation of public funds for scholarship students among the base school corporation, the receiving school corporation, and the parent. Requires the parent to provide student transportation. Provides that the laws concerning transfer students, including court ordered transfer students, do not apply to a student who attends a public school outside the student's base school corporation.

Effective: July 1, 2000.

A BILL FOR AN ACT to amend the Indiana Code concerning education.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 20-8.1-1-1.5 IS ADDED TO THE INDIANA
2 CODE AS A **NEW SECTION** TO READ AS FOLLOWS
3 [EFFECTIVE JULY 1, 2000]: **Sec. 1.5. As used in this article,**
4 **"ADM" has the meaning set forth in IC 21-3-1.6-1.1.**

5 SECTION 2. IC 20-8.1-6.1-0.5 IS ADDED TO THE INDIANA
6 CODE AS A **NEW SECTION** TO READ AS FOLLOWS
7 [EFFECTIVE JULY 1, 2000]: **Sec. 0.5. This chapter does not apply**
8 **to a student who under the public elementary and secondary school**
9 **scholarship program (IC 20-8.1-14) attends a public school that is**
10 **outside the school corporation where the student has legal**
11 **settlement.**

12 SECTION 3. IC 20-8.1-6.5-0.5 IS ADDED TO THE INDIANA
13 CODE AS A **NEW SECTION** TO READ AS FOLLOWS
14 [EFFECTIVE JULY 1, 2000]: **Sec. 0.5. This chapter does not apply**
15 **to a student who under the public elementary and secondary school**
16 **scholarship program (IC 20-8.1-14) attends a public school that is**
17 **outside the school corporation where the student has legal**

2 SECTION 4. IC 20-8.1-14 IS ADDED TO THE INDIANA CODE
3 AS A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE
4 JULY 1, 2000]:

5 **Chapter 14. Public Elementary and Secondary School**
6 **Scholarship Program**

7 **Sec. 1. As used in this chapter, "base school corporation" means**
8 **the school corporation where a student has legal settlement (as**
9 **defined in IC 20-8.1-1-7.1).**

10 **Sec. 2. As used in this chapter, "program" refers to the public**
11 **elementary and secondary school scholarship program.**

12 **Sec. 3. As used in this chapter, "public school" has the meaning**
13 **set forth in IC 20-10.1-1-2.**

14 **Sec. 4. As used in this chapter, "scholarship" refers to a**
15 **scholarship under the program.**

16 **Sec. 5. The public elementary and secondary school scholarship**
17 **program is established.**

18 **Sec. 6. On a date the department specifies that falls before the**
19 **beginning of a school year, the department shall grant scholarships**
20 **and renewal scholarships under this chapter.**

21 **Sec. 7. (a) The department shall grant a scholarship to a student**
22 **who meets the following requirements:**

23 (1) **The student's parent requests a scholarship for the**
24 **student.**

25 (2) **The student's parent selects a school for the student to**
26 **attend under the scholarship program.**

27 (3) **The school is a public school in Indiana that is:**
28 **(A) in the student's base school corporation but is a**
29 **different school from the school where the school**
30 **corporation has assigned the student; or**

31 **(B) not a school in the student's base school corporation.**

32 (4) **Except as provided in section 13(b) of this chapter, the**
33 **principal of the school and the superintendent of the school**
34 **corporation where the school is located jointly agree to enroll**
35 **the student in the school.**

36 (b) **The department shall grant a renewal scholarship to a**
37 **student who meets the following requirements:**

38 (1) **The student previously received a scholarship in any year.**

39 (2) **The requirements of subsection (a) are met.**

40 (c) **The department may not grant a scholarship to a student**
41 **who wishes to enroll in a school primarily for athletic reasons.**

42 **Sec. 8. Not later than April 1 before the beginning of a school**

1 year for which a parent seeks enrollment of a student under the
 2 scholarship program, the student's parent shall notify the
 3 superintendent of the school corporation in which the parent seeks
 4 to have the student enroll of the parent's request to have the
 5 student enrolled.

6 **Sec. 9. (a)** The superintendent of a school corporation where a
 7 parent seeks enrollment of a student under the scholarship
 8 program:

9 (1) is not required to enroll the student; and

10 (2) may not enroll the student if enrollment will cause the
 11 school corporation to be out of compliance with a court order,
 12 including a court order described in IC 20-8.1-6.5-1.

13 (b) A superintendent may not refuse to enroll a student in
 14 violation of IC 20-8.1-2.

15 (c) A superintendent shall notify a parent who makes a request
 16 under section 8 of this chapter of the superintendent's decision not
 17 later than thirty (30) days after receiving a request for enrollment
 18 under section 8 of this chapter.

19 **Sec. 10.** The following apply when a student uses a scholarship
 20 to enroll in a school in the student's base school corporation:

21 (1) There is no monetary scholarship award.

22 (2) There is no change in:

23 (A) the ADM of the school corporation; or

24 (B) state assistance to the school corporation.

25 (3) The school corporation is not required to provide
 26 transportation for the student.

27 **Sec. 11.** The following apply when a student uses a scholarship
 28 to enroll in a school that is not a school in the student's base school
 29 corporation:

30 (1) The amount of the scholarship award is fifty percent
 31 (50%) of the state aid per ADM provided under IC 21-3 to the
 32 student's base school corporation.

33 (2) The student remains in the ADM of the student's base
 34 school corporation until the earlier of the following:

35 (A) The date the student graduates from a high school.

36 (B) The date of the end of the school year during which the
 37 student becomes eighteen (18) years of age.

38 (3) The school that enrolls the student may not include the
 39 student in the school's ADM.

40 (4) The department shall do the following:

41 (A) Pay the amount of the scholarship to the school that
 42 enrolls the student.

- 1 **(B) Deduct the amount of the scholarship from the**
 2 **distribution of state aid to the student's base school**
 3 **corporation.**
- 4 **(5) The parent of the student is responsible for all costs of the**
 5 **student to attend the school that exceed the amount of the**
 6 **scholarship.**
- 7 **(6) The student's base school corporation and the school**
 8 **corporation that enrolls the student are not responsible for**
 9 **providing transportation for the student.**
- 10 **Sec. 12. Except as provided in section 13(b) of this chapter, at**
 11 **the end of each school year the superintendent of the school**
 12 **corporation that enrolls a student under the program and the**
 13 **principal of the school the student attends shall jointly:**
- 14 **(1) determine whether to enroll the student for the following**
 15 **school year; and**
- 16 **(2) inform the department of the decision.**
- 17 **Sec. 13. (a) The governing body of a school corporation may**
 18 **adopt a policy that sets guidelines to be used in determining**
 19 **whether:**
- 20 **(1) to accept a student for enrollment under the program; and**
 21 **(2) to continue a student's enrollment under the program.**
- 22 **(b) Notwithstanding sections 7(a)(4) and 12 of this chapter, a**
 23 **policy adopted under this section may provide that the governing**
 24 **body makes a determination of whether to enroll a student or**
 25 **continue a student's enrollment under the program.**
- 26 **Sec. 14. The department shall establish procedures for the**
 27 **administration of this chapter.**
- 28 **Sec. 15. The department may adopt rules under IC 4-22-2 to**
 29 **implement and administer the program.**
- 30 **SECTION 5. [EFFECTIVE JULY 1, 2000] (a) As used in this**
 31 **SECTION, "department" has the meaning set forth in**
 32 **IC 20-8.1-1-17.**
- 33 **(b) As used in this SECTION, "school year" has the meaning set**
 34 **forth in IC 20-10.1-2-1.**
- 35 **(c) The department shall grant scholarships under IC 20-8.1-14,**
 36 **as added by this act, beginning with the 2001-2002 school year.**
 37 **(d) This SECTION expires July 1, 2003.**
