## SENATE BILL No. 224

---

DIGEST OF SB 224 (Updated January 25, 2000 2:59 PM - DI 71)

**Citations Affected:** IC 20-10.1.

**Synopsis:** Military access to student information. Requires a high school to provide access to the high school campus and student directory information to official recruiting representatives of the armed forces, the Indiana Air and Army National Guards, and the service academies of the armed forces of the United States. Provides for exceptions. Allows high schools to charge official recruiting representatives a fee to cover copying and mailing costs.

**Effective:** July 1, 2000.

PRINTING CODE. Amendments: Whenever an existing statute (or a section of the Indiana Constitution) is being amended, the text of the existing provision will appear in this style type, additions will appear in **this style type**, and deletions will appear in ~~this style type~~.

Additions: Whenever a new statutory provision is being enacted (or a new constitutional provision adopted), the text of the new provision will appear in **this style type**. Also, the word **NEW** will appear in that style type in the introductory clause of each SECTION that adds a new provision to the Indiana Code or the Indiana Constitution.

Conflict reconciliation: Text in *this style type* or ~~this style type~~ reconciles conflicts between statutes enacted by the 1999 General Assembly.

## SENATE BILL No. 224

A BILL FOR AN ACT to amend the Indiana Code concerning education.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1 SECTION 1. IC 20-10.1-29-2 IS AMENDED TO READ AS  
2 FOLLOWS [EFFECTIVE JULY 1, 2000]: Sec. 2. As used in this  
3 chapter, "student directory information" means the student's name, ~~and~~  
4 address, **and telephone number**.
- 5 SECTION 2. IC 20-10.1-29-3 IS AMENDED TO READ AS  
6 FOLLOWS [EFFECTIVE JULY 1, 2000]: Sec. 3. ~~If a high school~~  
7 ~~allows any person to have access to the high school campus or the high~~  
8 ~~school's student directory information to make students aware of~~  
9 ~~educational or occupational options offered by the person; the (a)~~  
10 **Except as provided in subsection (b), a high school shall provide**  
11 **access to the high school campus ~~or~~ and the high school's student**  
12 **directory information ~~on the same basis~~ to official recruiting**  
13 **representatives of:**
- 14 (1) the armed forces of the United States;
  - 15 (2) the Indiana Air National Guard; ~~and~~
  - 16 (3) the Indiana Army National Guard; **and**
  - 17 (4) **the service academies of the armed forces of the United**

 17           **the parents, guardians, or custodians of students of the provisions**  
 18           **of this subsection.**

19           **(c) A high school may require an official recruiting**  
 20           **representative to pay a fee:**

21                 **(1) for copying and mailing the high school's student directory**  
 22                 **information described under subsection (a); and**  
 23                 **(2) in an amount that is not more than the actual costs**  
 24                 **incurred by the high school.**

25           SECTION 3. IC 20-10.1-29-4 IS ADDED TO THE INDIANA  
 26           CODE AS A NEW SECTION TO READ AS FOLLOWS  
 27           [EFFECTIVE JULY 1, 2000]: **Sec. 4. Information received by an**  
 28           **official recruiting representative under section 3 of this chapter:**

29                 **(1) may be used only to provide information to students**  
 30                 **concerning educational and career opportunities available in**  
 31                 **the armed forces of the United States, the Indiana Air**  
 32                 **National Guard, the Indiana Army National Guard, and the**  
 33                 **service academies of the armed forces of the United States;**  
 34                 **and**

35                 **(2) may not be released to a person who is not involved in**  
 36                 **recruiting high school students for the armed forces of the**  
 37                 **United States, the Indiana Air National Guard, the Indiana**  
 38                 **Army National Guard, and the service academies of the**  
 39                 **armed forces of the United States.**
