SENATE BILL No. 257

DIGEST OF SB 257 (Updated January 27, 2000 11:55 AM - DI 44)

Citations Affected: IC 4-4; noncode.

Synopsis: Rural economic development. Provides that the Indiana rural development council shall develop a rural economic development strategy to assist Indiana's rural residents in improving their quality of life and help promote successful and sustainable rural communities. Provides that the rural economic development strategy must include goals and recommendations concerning certain issues. Provides that the Indiana rural development council shall, before December 1 of each year, submit an annual report to the legislative council to inform the general assembly of the council's work during the period covered by the report and to assist the general assembly in monitoring issues affecting rural communities and responding to the needs of rural residents. Appropriates \$300,000 from the state general fund for the 2000-2001 fiscal year to the Indiana rural development council for preparing rural development strategy.

Effective: July 1, 2000.

SENATE BILL No. 257



A BILL FOR AN ACT to amend the Indiana Code concerning economic development and to make an appropriation.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 4-4-9.5 IS ADDED TO THE INDIANA CODE AS
2 A **NEW** CHAPTER TO READ AS FOLLOWS [EFFECTIVE JULY
3 1, 2000]:

4 **Chapter 9.5. Indiana Rural Development Council**

5 **Sec. 1. As used in this chapter, "council" refers to the Indiana**
6 **Rural Development Council established by the 1993 memorandum**
7 **of understanding between Indiana and the United States**
8 **Department of Agriculture.**

9 **Sec. 2. With the approval of the governing board of the council,**
10 **the council shall do the following:**

11 (1) **Develop a rural economic development strategy for**
12 **Indiana to assist Indiana's rural residents in improving their**
13 **quality of life and to help promote successful and sustainable**
14 **rural communities. The rural economic development strategy**
15 **must include goals and recommendations concerning the**
16 **following issues:**

17 (A) **Job creation and retention.**

- 21 SECTION 2. [EFFECTIVE JULY 1, 2000] (a) As used in this
- 22 SECTION, "council" has the meaning set forth in IC 4-4-9.5-1, as
- 23 added by this act.
- 24 (b) There is appropriated to the council from the state general
- 25 fund three hundred thousand dollars (\$300,000) beginning July 1,
- 26 2000, and ending June 30, 2001.
- 27 (c) The council may use money appropriated under this
- 28 SECTION for the purpose of preparing the rural economic
- 29 development strategy required by IC 4-4-9.5, as added by this act.
- 30 (d) This SECTION expires July 1, 2001.
