DIGEST OF SB 271 (Updated January 18, 2000 2:45 PM - DI 69)

**Citations Affected:** IC 35-41.

**Synopsis:** Federal enforcement officers. Adds United States Immigration and Naturalization Service special agent to the definition of "federal enforcement officer" for purposes of Title 35 of the Indiana Code concerning criminal law and procedure and all other statutes relating to penal offenses.

**Effective:** July 1, 2000.

PRINTING CODE. Amendments: Whenever an existing statute (or a section of the Indiana Constitution) is being amended, the text of the existing provision will appear in this style type, additions will appear in **this style type**, and deletions will appear in ~~this style type~~.

Additions: Whenever a new statutory provision is being enacted (or a new constitutional provision adopted), the text of the new provision will appear in **this style type**. Also, the word **NEW** will appear in that style type in the introductory clause of each SECTION that adds a new provision to the Indiana Code or the Indiana Constitution.

Conflict reconciliation: Text in a statute in *this style type* or ~~this style type~~ reconciles conflicts between statutes enacted by the 1999 General Assembly.

## SENATE BILL No. 271

A BILL FOR AN ACT to amend the Indiana Code concerning criminal law and procedure.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1 SECTION 1. IC 35-41-1-17 IS AMENDED TO READ AS  
2 FOLLOWS [EFFECTIVE JULY 1, 2000]: Sec. 17. (a) "Law  
3 enforcement officer" means:  
4 (1) a police officer, sheriff, constable, marshal, or prosecuting  
5 attorney;  
6 (2) a deputy of any of those persons;  
7 (3) an investigator for a prosecuting attorney;  
8 (4) a conservation officer; or  
9 (5) an enforcement officer of the alcoholic beverage commission.  
10 (b) "Federal enforcement officer" means any of the following:  
11 (1) A Federal Bureau of Investigation special agent.  
12 (2) A United States Marshals Service marshal or deputy.  
13 (3) A United States Secret Service special agent.  
14 (4) A United States Fish and Wildlife Service special agent.  
15 (5) A United States Drug Enforcement Agency agent.  
16 (6) A Bureau of Alcohol, Tobacco, and Firearms agent.  
17 (7) A United States Forest Service law enforcement officer.
