

COMMITTEE REPORT

MR. PRESIDENT:

The Senate Committee on Governmental and Regulatory Affairs, to which was referred House Bill No. 1202, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:

- 1 Page 3, after line 42, begin a new paragraph and insert:
2 "SECTION 4. IC 12-20-21-5 IS AMENDED TO READ AS
3 FOLLOWS [EFFECTIVE JANUARY 1, 2001]: Sec. 5. The township

- 19 SECTION 12. [EFFECTIVE JANUARY 1, 2001] **(a) For each**
- 20 **township contained in a particular county, the county auditor shall**
- 21 **determine the amount, if any, of the unencumbered balance, held**
- 22 **by the county, in the township's poor relief account as of January**
- 23 **1, 2001. The county shall transfer the amount determined for each**
- 24 **township to the respective township by not later than January 10,**
- 25 **2001.**
- 26 **(b) This SECTION expires January 11, 2001."**
- 27 Renumber all SECTIONS consecutively.
