I move that Engrossed Senate Bill 283 be amended to read as follows:

- 1 Page 2, delete lines 2 through 26, begin a new paragraph and insert:
- 2 "SECTION 2. IC 13-21-3-1 IS AMENDED TO READ AS
- 3 FOLLOWS [EFFECTIVE UPON PASSAGE]: Sec. 1. (a) **Except as**
- 4 **provided in subsection (b)**, each county shall, by ordinance of the
- 5 county executive:
- 6 (1) join with one (1) or more other counties in establishing a joint
- 7 solid waste management district that includes the entire area of all
- 8 the acting counties; or
- 9 (2) designate itself as a county solid waste management district.
- 10 (b) **Notwithstanding subsection (a)(1), if a county withdraws**
- 11 **from a joint solid waste management district under IC 13-21-4, the**
- 12 **county executive of the county may adopt an ordinance to join**

- 15 (1) **not earlier than fifteen (15) days; or**
- 16 (2) **not later than forty-five (45) days;**
