Whereas, the Burris Volleyball Team had a record of 34-5; and

Whereas, the team defeated Mitchell (previously undefeated at 34-0) in the state championship game at historic Hinkle Fieldhouse in Indianapolis, 15-3, 15-3; and

Whereas, this was the thirteenth State Championship in Volleyball for Muncie Burris; and

Whereas, Muncie Burris has won the State Championship in Volleyball for the fifth straight time; and

Whereas, the team won 30 or more matches for the 20th straight year; and
