HOUSE MOTION _____

MR. SPEAKER:

I move that House Bill 1565 be amended to read as follows:

- 1 Delete everything after the enacting clause and insert the following:
2 SECTION 1. IC 25-22.5-5-4.5 IS ADDED TO THE INDIANA
3 CODE AS A NEW SECTION TO READ AS FOLLOWS
4 [EFFECTIVE JULY 1, 2003]: **Sec. 4.5. (a) The board may authorize**
5 **the health professions bureau to issue temporary fellowship**
6 **permits for the practice of medicine. A temporary fellowship is**
7 **subject to any termination date specified by the board.**
8 **(b) The board may issue a temporary fellowship permit to a**
9 **graduate of a school located outside the United States, its**
10 **possessions, or Canada if the graduate:**
11 **(1) applies in the form and manner required by the board;**
12 **(2) pays a fee set by the board;**
13 **(3) has completed the academic requirements for the degree**
14 **of doctor of medicine from a medical school approved by the**
15 **board;**
16 **(4) has been issued a valid permit by another state for**
17 **participation in a postgraduate medical education or training**
18 **program located in a state that has standards for**
19 **postgraduate medical education and training satisfactory to**
20 **the board;**
21 **(5) has been accepted into a postgraduate medical fellowship**
22 **training program that:**
23 **(A) is affiliated with a medical school located in a state that**
24 **issued a permit under subdivision (4);**

- 1 **(B) has a training site located in Indiana; and**
- 2 **(C) has standards for postgraduate medical education and**
- 3 **training satisfactory to the board;**
- 4 **(6) provides the board with documentation of the areas of**
- 5 **medical practice for which the training is sought;**
- 6 **(7) provides the board with at least two (2) letters of reference**
- 7 **documenting the individual's character; and**
- 8 **(8) demonstrates to the board that the individual is a**
- 9 **physician of good character who is in good standing outside**
- 10 **the United States, its possessions, or Canada where the person**
- 11 **normally would practice.**

12 **(c) Applications for the temporary fellowship permit for**
 13 **graduates of foreign medical schools must be made to the board**
 14 **subject to this section.**

15 **(d) A permit issued under this section expires one (1) year after**
 16 **the date it is issued and, at the discretion of the board, may be**
 17 **renewed for additional one (1) year periods upon the payment of**
 18 **a renewal fee set by the board by rule.**

19 **(e) An individual who applies for a temporary fellowship permit**
 20 **under this section is not required to take any step of the United**
 21 **States Medical Licensure Examination.**

22 **(f) A temporary fellowship permit must be kept in the**
 23 **possession of the fellowship training institution and surrendered by**
 24 **it to the board within thirty (30) days after the person ceases**
 25 **training in Indiana.**

26 **(g) A temporary fellowship permit authorizes a person to**
 27 **practice in the training institution only and, in the course of**
 28 **training, to practice only those medical acts approved by the**
 29 **board, but does not authorize the person to practice medicine**
 30 **otherwise.**

31 **(h) The board may deny an application for a temporary**
 32 **fellowship permit if the training program that has accepted the**
 33 **applicant has:**

- 34 **(1) violated; or**
- 35 **(2) authorized or permitted a physician to violate;**
- 36 **this section.**

37 **(i) An individual issued a temporary fellowship permit under**
 38 **this section must file an affidavit that:**

- 39 **(1) is signed by a physician licensed under IC 25-22.5;**
- 40 **(2) includes the license number of the signing physician;**
- 41 **(3) attests that the signing physician will monitor the work of**
- 42 **the individual holding the temporary fellowship permit; and**
- 43 **(4) is notarized.**

44 **The affidavit must be filed with the health professions bureau**
 45 **before the individual holding the temporary fellowship permit may**
 46 **provide medical services.**
