- 1 Page 2, line 8, after "Sec. 2." insert "(a)".
- 2 Page 2, between lines 9 and 10, begin a new paragraph and insert:
- 3 **"(b) The secretary and the director of the state budget agency**
- 4 **are responsible for ensuring that the cost of the services provided**
- 5 **under this chapter does not exceed the total amount of funding,**
- 6 **including state and federal funds, that is made available by the**
- 7 **budget agency for the program established under this chapter to**
- 8 **provide long term care, including home and community based**
- 9 **services."**
- 10 Page 3, between lines 16 and 17, begin a new paragraph and insert:
- 11 **"(b) The secretary shall annually report to the governor, the**
- 12 **budget agency, the budget committee, the select commission on**
- 13 **Medicaid oversight, and the executive director of the legislative**
- 14 **services agency the savings determined under subsection (a)."**

- 1 Page 3, line 17, delete "(b)" and insert "(c)".
- 2 Page 4, line 9, delete "state".
- 3 Page 4, line 10, delete "program." and insert "**program that is**
- 4 **appropriated by the general assembly.**".
- 5 Page 4, line 11, delete "sixty (60)" and insert "**sixty-five (65)**".
- 6 Page 5, line 32, delete "December 31," and insert "**July 1,**".
- 7 Page 6, line 4, delete "slots." and insert "**slots at no additional cost**
- 8 **to the state.**".
- 9 Page 6, line 19, delete "December 31," and insert "**July 1,**".
- 10 Page 7, between lines 16 and 17, begin a new paragraph and insert:
- 11 "**(h) This SECTION expires July 1, 2005.**".
- 12 Page 7, line 28, after "[EFFECTIVE JULY 1, 2003]" insert "(a)".
- 13 Page 7, between lines 33 and 34, begin a new paragraph and insert:
- 14 "**(b) This SECTION expires July 1, 2005.**".
- 15 Page 7, line 39, after "based group" insert ",".
- 16 Page 8, between lines 40 and 41, begin a new paragraph and insert:
- 17 "**(b) This SECTION expires July 1, 2005.**".
