DIGEST OF INTRODUCED BILL

Citations Affected: IC 4-32-9.

Synopsis: Charitable gaming. Permits a bona fide veterans organization to pay operators and workers at the organization's charity gaming events and to hire nonmembers as workers at the events.

Effective: July 1, 2003.

SENATE BILL No. 193



A BILL FOR AN ACT to amend the Indiana Code concerning gaming.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 4-32-9-25 IS AMENDED TO READ AS
 2 FOLLOWS [EFFECTIVE JULY 1, 2003]: Sec. 25. (a) Except as
 3 provided in subsection (b) **and section 35 of this chapter**, an operator
 4 or a worker may not receive remuneration for:
 5 (1) preparing for;
 6 (2) conducting;
 7 (3) assisting in conducting;
 8 (4) cleaning up after; or
 9 (5) taking any other action in connection with;
 10 an allowable event.
 11 (b) A qualified organization that conducts an allowable event may:
 12 (1) provide meals for the operators and workers during the
 13 allowable event; and
 14 (2) provide recognition dinners and social events for the operators
 15 and workers;
 16 if the value of the meals and social events does not constitute a
 17 significant inducement to participate in the conduct of the allowable



1 event.

2 SECTION 2. IC 4-32-9-29 IS AMENDED TO READ AS
3 FOLLOWS [EFFECTIVE JULY 1, 2003]: Sec. 29. **Except as**
4 **provided in section 35 of this chapter**, a worker must be a member in
5 good standing of a qualified organization that is conducting an
6 allowable event for at least thirty (30) days at the time of the allowable
7 event.

8 SECTION 3. IC 4-32-9-35 IS ADDED TO THE INDIANA CODE
9 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
10 1, 2003]: Sec. 35. **(a) This section applies only to an allowable event**
11 **conducted by a qualified organization that is a bona fide veterans**
12 **organization (as defined in IC 4-32-6-10).**

13 **(b) An operator or a worker may receive remuneration for:**
14 **(1) preparing for;**
15 **(2) conducting;**
16 **(3) assisting in conducting;**
17 **(4) cleaning up after; or**
18 **(5) taking any other action in connection with;**
19 **an allowable event conducted by a qualified organization that is a**
20 **bona fide veterans organization.**

21 **(c) A worker at an allowable event conducted by a qualified**
22 **organization that is a bona fide veterans organization is not**
23 **required to be a member in good standing of the qualified**
24 **organization.**
