### DIGEST OF INTRODUCED BILL

**Citations Affected:** IC 10-2-4-24; IC 33-1-18.

**Synopsis:** National guard benefits. Extends the protections of the federal Soldiers' and Sailors' Civil Relief Act and the Uniformed Services Employment and Reemployment Rights Act to members of the Indiana national guard who are ordered to active duty by the governor.

**Effective:** July 1, 2003.

## SENATE BILL No. 365



A BILL FOR AN ACT to amend the Indiana Code concerning state police, civil defense and military affairs.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1 SECTION 1. IC 10-2-4-24 IS ADDED TO THE INDIANA CODE
- 2 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
- 3 1, 2003]: **Sec. 24. (a) As used in this section, "active duty" means:**
- 4 **(1) training or duty under federal law; or**
- 5 **(2) state active duty under section 4 of this chapter;**
- 6 **performed under an order of the governor.**
- 7 **(b) The rights, benefits, and protections of the federal Soldiers'**
- 8 **and Sailors' Civil Relief Act, 50 U.S.C. App. 501 et seq., as**
- 9 **amended and in effect on January 1, 2003, apply to a member of**
- 10 **the Indiana national guard ordered to active duty for at least thirty**
- 11 **(30) consecutive days.**
- 12 **(c) The rights, benefits, and protections of the federal**
- 13 **Uniformed Services Employment and Reemployment Rights Act,**
- 14 **38 U.S.C. 4301 et seq., as amended and in effect on January 1,**
- 15 **2003, apply to a member of the Indiana national guard ordered to**
- 16 **active duty.**
- 17 **(d) Nothing in this section shall be construed as a restriction or**



1 **limitation on any of the rights, benefits, and protections granted to**  
 2 **a member of the Indiana national guard under federal law.**  
 3 SECTION 2. IC 33-1-18 IS ADDED TO THE INDIANA CODE AS  
 4 A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE JULY  
 5 1, 2003]:  
 6 **Chapter 18. Protection of Indiana National Guard Members on**  
 7 **Active Duty**  
 8 **Sec. 1. (a) An Indiana state court may grant the rights, benefits,**  
 9 **and protections described in section 513 of the federal Soldiers'**  
 10 **and Sailors' Civil Relief Act, 50 U.S.C. App. 513, as amended and**  
 11 **in effect on January 1, 2003, to a person primarily or secondarily**  
 12 **liable on an obligation or liability of an Indiana national guard**  
 13 **member to whom IC 10-2-4-24 applies.**  
 14 **(b) All rights, benefits, and protections granted to a person**  
 15 **under subsection (a) are in addition to the rights, benefits, and**  
 16 **protections granted the person under the federal Soldiers' and**  
 17 **Sailors' Civil Relief Act, 50 U.S.C. App. 501 et seq., as amended**  
 18 **and in effect on January 1, 2003.**
