MR. PRESIDENT:

I move that Engrossed House Bill 1082 be amended to read as follows:

- 1 Page 4, line 9, after "possesses" insert "**more than fifteen (15)**

- 6 Page 4, line 9, reset in roman "anhydrous ammonia or ammonia".
- 7 Page 4, line 10, reset in roman "solution (as defined in IC 22-11-20-
- 8 1)".
- 9 Page 4, line 10, delete "one (1) or more chemical".
- 10 Page 4, line 11, delete "reagents or precursors".
- 11 Page 4, line 15, after "possessing" insert "**more than fifteen (15)**
- 12 **grams of ephedrine, pseudoephedrine or phenylpropanolamine, the**
- 13 **salts, isomers or salts of isomers of ephedrine, pseudoephedrine or**
- 14 **phenylpropanolamine or a combination of any of these substances**

- 19 Page 4, line 16, delete "one (1) or more chemical".
- 20 Page 4, line 17, delete "reagents or precursors".
- 21 Page 4, line 20, after "(2)" insert "**more than fifteen (15) grams of**
- 22 **ephedrine, pseudoephedrine or phenylpropanolamine, the salts,**
- 23 **isomers or salts of isomers of ephedrine, pseudoephedrine or**
- 24 **phenylpropanolamine or a combination of any of these substances**
- 25 **exceeding fifteen (15) grams or"**.
- 26 Page 4, line 20, reset in roman "anhydrous ammonia or ammonia
- 27 solution (as defined in".
- 28 Page 4, line 21, reset in roman "IC 22-11-20-1)".
- 29 Page 4, line 21, delete "one (1) or more chemical reagents or".
- 30 Page 4, line 22, delete "precursors".
- 31 Page 4, between lines 28 and 29, begin a new paragraph and insert:
- 32 "**(c) Subsection (b) does not apply to a physician, pharmacist,**

1 **retail distributor, wholesaler, manufacturer, warehouseman or**
2 **common carrier or an agent of any of these persons if the**
3 **possession is in the regular course of lawful business activities."**

4 Page 4, line 29, strike "(c)" and insert "(d)".

5 Page 5, line 11, delete "(d)" and insert "(e)".
