

**CONFERENCE COMMITTEE REPORT
DIGEST FOR EHB 1254**

Citations Affected: IC 9-13-2; IC 9-24; IC 9-27-4-4.

Synopsis: Driver's licensing matters. Allows the bureau of motor vehicles to adopt rules to comply with federal requirements concerning background checks for an individual seeking a hazardous materials endorsement for a commercial driver's license. Specifies that a learner's permit holder who: (1) is less than 18 years old and holds a validated permit; or (2) is enrolled in an approved driver's education course; may drive a motor vehicle when the seat beside the driver's seat is occupied by a stepparent of the permit holder who holds a valid operator's license. Permits a licensed commercial driver training school to conduct classroom training in a county outside the county in which the school is located. Revises the definition of approved motorcycle driver education and training course to include a course offered by a new motorcycle dealer. **(This conference committee report inserts the contents of the January 23, 2004, version of SB 395, concerning motorcycle driver education.)**

Effective: Upon passage; July 1, 2004.

CONFERENCE COMMITTEE REPORT

MADAM PRESIDENT:

Your Conference Committee appointed to confer with a like committee from the House upon Engrossed Senate Amendments to Engrossed House Bill No. 1254 respectfully reports that said two committees have conferred and agreed as follows to wit:

that the House recede from its dissent from all Senate amendments and that the House now concur in all Senate amendments to the bill and that the bill be further amended as follows:

- 1 Delete everything after the enacting clause and insert the following:
- 2 SECTION 1. IC 9-13-2-1.1 IS ADDED TO THE INDIANA CODE
- 3 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
- 4 1, 2004]: **Sec. 1.1. "Act", for purposes of IC 9-24-6.5, has the**
- 5 **meaning set forth in IC 9-24-6.5-1.**
- 6 SECTION 2. IC 9-13-2-1.5 IS ADDED TO THE INDIANA CODE
- 7 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
- 8 1, 2004]: **Sec. 1.5. "Administration", for purposes of IC 9-24-6.5,**
- 9 **has the meaning set forth in IC 9-24-6.5-2.**
- 10 SECTION 3. IC 9-13-2-5 IS AMENDED TO READ AS FOLLOWS
- 11 [EFFECTIVE UPON PASSAGE]: Sec. 5. "Approved motorcycle driver
- 12 education and training course" means:
- 13 (1) a course offered by a public or private secondary school, **a new**
- 14 **motorcycle dealer**, or other driver education school offering
- 15 motorcycle driver training as developed and approved by the
- 16 superintendent of public instruction and the bureau; or
- 17 (2) a course that is offered by a commercial driving school or new
- 18 motorcycle dealer and that is approved by the bureau.
- 19 SECTION 4. IC 9-24-6-11.5 IS ADDED TO THE INDIANA CODE
- 20 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY

1 1, 2004]: **Sec. 11.5. (a) This section applies if the United States**
 2 **Department of Homeland Security, Transportation Security**
 3 **Administration adopts regulations concerning disqualifying**
 4 **offenses.**

5 **(b) The bureau shall revoke the hazardous materials**
 6 **endorsement of a driver who:**

7 **(1) receives a judgment or conviction for a disqualifying**
 8 **offense (as defined in the regulations described in subsection**
 9 **(a) immediately upon receiving notice of the judgment or**
 10 **conviction; or**

11 **(2) is determined by the United States Department of**
 12 **Homeland Security, Transportation Security Administration**
 13 **to be a potential security threat;**

14 **and shall give notice to the driver that the endorsement has been**
 15 **revoked and of the procedure by which the driver may appeal the**
 16 **revocation.**

17 **(c) The revocation of the hazardous material endorsement of a**
 18 **driver revocation under subsection (b) is for the period set forth**
 19 **under the regulations described in subsection (a).**

20 SECTION 5. IC 9-24-6-12, AS AMENDED BY P.L.123-2002,
 21 SECTION 16, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
 22 JULY 1, 2004]: Sec. 12. (a) A driver who:

23 (1) is:

24 (A) convicted of an offense described in section 8(1) through
 25 8(4) or 8(6) of this chapter; or

26 (B) found to have violated section 8(7) of this chapter; and

27 (2) has been previously convicted in a separate incident of any
 28 offense described in section 8(1) through 8(4) or 8(6) of this
 29 chapter;

30 is disqualified for life from driving a commercial motor vehicle.

31 (b) A driver who applies for a hazardous materials endorsement and
 32 has been convicted of:

33 (1) a felony under Indiana law that results in serious bodily injury
 34 or death to another person; or

35 (2) a crime in any other jurisdiction in which the elements of the
 36 crime for which the conviction was entered are substantially similar
 37 to the elements of a felony described in subdivision (1);

38 is disqualified for life from holding a hazardous materials endorsement.

39 (c) The hazardous materials endorsement of a driver who holds a
 40 hazardous materials endorsement and is convicted of a:

41 (1) felony under Indiana law that results in serious bodily injury or
 42 death to another person; or

43 (2) crime in any other jurisdiction in which the elements of the
 44 crime for which the conviction was entered are substantially similar
 45 to the elements of a felony described in subdivision (1);

46 is revoked upon conviction, and the driver is disqualified for life from
 47 holding a hazardous materials endorsement.

48 **(d) The hazardous materials endorsement of a driver may be**
 49 **revoked and the driver may be disqualified from holding a**

1 **hazardous materials endorsement if the revocation and**
2 **disqualification are required under regulations adopted by the**
3 **United States Department of Homeland Security, Transportation**
4 **Security Administration.**

5 SECTION 6. IC 9-24-6.5 IS ADDED TO THE INDIANA CODE AS
6 A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE JULY 1,
7 2004]:

8 **Chapter 6.5. Hazardous Material Endorsement Application and**
9 **Renewal**

10 **Sec. 1. As used in this chapter, "act" refers to the federal**
11 **Uniting and Strengthening America by Providing Appropriate**
12 **Tools Required to Intercept and Obstruct Terrorism Act, Pub. L.**
13 **107-56, 115 Stat. 272 (2001).**

14 **Sec. 2. As used in this chapter, "administration" refers to the**
15 **United States Department of Homeland Security, Transportation**
16 **Security Administration.**

17 **Sec. 3. The bureau may adopt rules and policies necessary to**
18 **fully implement the requirements of the act and the regulations**
19 **adopted to implement the act.**

20 **Sec. 4. The bureau shall forward the information provided by an**
21 **applicant for a hazardous material endorsement to the**
22 **administration or another agency designated to receive the**
23 **information if the bureau is required to forward the information**
24 **under regulations adopted to implement the act.**

25 **Sec. 5. The bureau may:**

26 **(1) determine the cost to the state of procedures required to**
27 **comply with regulations adopted to implement the act; and**

28 **(2) charge a fee to applicants that is sufficient to offset the**
29 **cost determined under subdivision (1).**

30 **Sec. 6. (a) The hazardous materials endorsement of a driver who**
31 **applies for renewal of the endorsement may remain valid after the**
32 **date on which the endorsement would otherwise expire if both of**
33 **the following conditions are met:**

34 **(1) The application for renewal was received by the bureau at**
35 **least ninety (90) days before the date on which the**
36 **endorsement expires.**

37 **(2) On the date on which the endorsement expires, the bureau**
38 **has not yet received the results of a background check**
39 **conducted by the administration or another agency designated**
40 **to conduct the background check.**

41 **(b) Except as provided in subsection (c), an extension under**
42 **subsection (a) is valid for ninety (90) days after the date on which**
43 **the endorsement would otherwise expire.**

44 **(c) Notwithstanding subsection (b), if the bureau receives**
45 **information from the administration or another agency designated**
46 **to conduct a background check that requires the bureau to revoke**
47 **the hazardous materials endorsement of a driver, the bureau shall**

1 **revoke the endorsement immediately upon receipt of the**
 2 **information.**

3 **(d) An extension under subsection (a) may be renewed until:**

4 **(1) the bureau receives the results of a background check**
 5 **conducted by the administration or another agency designated**
 6 **to conduct the background check; or**

7 **(2) further extensions are barred under regulations adopted**
 8 **to implement the act.**

9 **Sec. 7. An applicant whose application for a hazardous materials**
 10 **endorsement is denied or whose hazardous materials endorsement**
 11 **is revoked under IC 9-24-6-11.5 may appeal the denial or**
 12 **revocation under IC 4-21.5 or, if other procedures are adopted by**
 13 **the administration or another agency of the United States, under**
 14 **the other procedures.**

15 SECTION 7. IC 9-24-7-4 IS AMENDED TO READ AS FOLLOWS
 16 [EFFECTIVE JULY 1, 2004]: Sec. 4. A learner's permit authorizes the
 17 permit holder to operate a motor vehicle, except a motorcycle, upon a
 18 public highway under the following conditions:

19 (1) While the holder is participating in practice driving in an
 20 approved driver education course and is accompanied by a certified
 21 driver education instructor in the front seat of an automobile
 22 equipped with dual controls.

23 (2) If the learner's permit has been validated and the holder is less
 24 than eighteen (18) years of age, the holder may participate in
 25 practice driving if the seat beside the holder is occupied by a
 26 guardian, **stepparent**, or relative of the holder who holds a valid
 27 operator's, chauffeur's, or public passenger chauffeur's license.

28 (3) If the learner's permit has been validated and the holder is at
 29 least eighteen (18) years of age, the holder may participate in
 30 practice driving if accompanied in the vehicle by an individual who
 31 holds a valid operator's, chauffeur's, or public passenger
 32 chauffeur's license.

33 (4) While:

34 (A) the holder is enrolled in an approved driver education course;

35 (B) the holder is participating in practice driving after having
 36 commenced an approved driver education course; and

37 (C) the seat beside the holder is occupied by a parent,
 38 **stepparent**, or guardian of the holder who holds a valid
 39 operator's, chauffeur's, or public passenger chauffeur's license.

40 SECTION 8. IC 9-27-4-4 IS AMENDED TO READ AS FOLLOWS
 41 [EFFECTIVE UPON PASSAGE]: Sec. 4. (a) To establish or operate a
 42 commercial driver training school, the school must obtain a license
 43 from the bureau in the manner and form prescribed by the bureau.

44 (b) **Subject to subsection (c)**, the bureau shall adopt rules under
 45 IC 4-22-2 that state the requirements for obtaining a school license,
 46 including the following:

47 (1) Location of the school.

48 (2) Equipment required.

49 (3) Courses of instruction.

- 1 (4) Instructors.
 2 (5) Previous records of the school and instructors.
 3 (6) Financial statements.
 4 (7) Schedule of fees and charges.
 5 (8) Character and reputation of the operators and instructors.
 6 (9) Insurance in the amount and with the provisions the bureau
 7 considers necessary to adequately protect the interests of the
 8 public.
 9 (10) Other matters the bureau prescribes for the protection of the
 10 public.

11 **(c) The rules adopted under subsection (b) must permit a**
 12 **licensed school to conduct classroom training in a county outside**
 13 **the county where the school is located to the students of:**

- 14 **(1) a school corporation (as defined in IC 36-1-2-17);**
 15 **(2) a nonpublic secondary school that voluntarily becomes**
 16 **accredited under IC 20-1-1-6; or**
 17 **(3) a nonpublic secondary school recognized under**
 18 **IC 20-1-1-6.2;**

19 **if the governing body of the school corporation or the nonpublic**
 20 **secondary school approves the delivery of the training to its**
 21 **students.**

22 SECTION 9. [EFFECTIVE UPON PASSAGE] **(a) Notwithstanding**
 23 **IC 9-27-4-4, as amended by this act, the bureau of motor vehicles**
 24 **shall carry out the duties imposed upon it under IC 9-27-4-4, as**
 25 **amended by this act, under interim written guidelines approved by**
 26 **the commissioner of the bureau of motor vehicles.**

27 **(b) This SECTION expires on the earlier of the following:**

- 28 **(1) The date rules are adopted under IC 9-27-4-4, as amended**
 29 **by this act.**
 30 **(2) December 31, 2004.**

31 SECTION 10. **An emergency is declared for this act.**
 (Reference is to EHB 1254 as printed February 20, 2004.)
