

# COMMITTEE REPORT

---

## MADAM PRESIDENT:

The Senate Committee on Elections and Civic Affairs, to which was referred Senate Bill No. 382, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:

- 1 Page 2, line 36, delete "This" and insert "**Except as provided in**
- 2 **section 6.1 of this chapter, this**".
- 3 Page 2, line 37, delete "convicted of a crime before July 1, 2004,".
- 4 Page 3, line 7, delete "crime" and insert "**felony**".
- 5 Page 3, line 18, delete "crime" and insert "**felony**".
- 6 Page 3, delete lines 29 through 34.
- 7 Page 3, line 39, delete "crime" and insert "**felony**",
- 8 Page 4, delete lines 6 through 42.
- 9 Page 5, delete lines 1 through 30, begin a new paragraph and insert:
- 10 "SECTION 5. IC 3-7-46-6.2 IS ADDED TO THE INDIANA CODE
- 11 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
- 12 1, 2004]: **Sec. 6.2. (a) This section applies to each department,**
- 13 **office, or agency that supervises or is responsible for persons**
- 14 **convicted of a felony who are placed:**
- 15 **(1) in lawful detention other than:**
- 16 **(A) a department of correction facility; or**
- 17 **(B) a county correctional facility;**
- 18 **(2) on probation;**
- 19 **(3) on parole;**

- 1           **(4) on home detention under IC 35-38-2.5; or**  
 2           **(5) in a community corrections program under IC 35-38-2.6.**  
 3           **(b) This section does not apply to a county sheriff who submits**  
 4 **a report under section 6 of this chapter concerning persons placed**  
 5 **in a county correctional facility.**  
 6           **(c) Not later than:**  
 7           **(1) January 31;**  
 8           **(2) April 30;**  
 9           **(3) July 31; or**  
 10           **(4) October 31;**  
 11 **of each year, the departments, offices, or agencies described in**  
 12 **subsection (a) shall provide the county voter registration office**  
 13 **with a report containing the information set forth in subsection**  
 14 **(d) for those persons the department, office, or agency supervises**  
 15 **or is responsible for processing under section 8 of this chapter.**  
 16           **(d) The report required by subsection (c) must identify each**  
 17 **person the department, office, or agency supervises or is**  
 18 **responsible for who:**  
 19           **(1) is a resident of Indiana;**  
 20           **(2) has been convicted of a felony in the county; and**  
 21           **(3) has been placed:**  
 22           **(A) in lawful detention other than:**  
 23           **(i) a department of correction facility; or**  
 24           **(ii) a county correctional facility;**  
 25           **(B) on probation;**  
 26           **(C) on parole;**  
 27           **(D) on home detention under IC 35-38-2.5; or**  
 28           **(E) in a community corrections program under**  
 29           **IC 35-38-2.6;**  
 30 **during the previous quarter.**

31           SECTION 6. IC 3-7-46-7, AS AMENDED BY P.L.209-2003,  
 32 SECTION 90, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
 33 JULY 1, 2004]: Sec. 7. The county voter registration office shall notify  
 34 the county voter registration office of each county where a person on  
 35 the list resides that a voter registered in that county has been listed on  
 36 the report described in section 6 **or 6.2** of this chapter."

37           Page 5, line 33, after "5" insert ",".

38           Page 5, line 34, reset in roman "6".

39           Page 5, line 34, after "6" insert ", **or 6.2**".



- 1 Page 5, delete line 42.
- 2 Page 6, delete line 1.
- 3 Renumber all SECTIONS consecutively.  
(Reference is to SB 382 as introduced.)
