MR. SPEAKER:

I move that House Bill 1381 be amended to read as follows:

- 1 Page 3, between lines 5 and 6, begin a new paragraph and insert:
- 2 "SECTION 3. IC 13-11-2-245 IS AMENDED TO READ AS
- 3 FOLLOWS [EFFECTIVE JULY 1, 2005]: Sec. 245. (a) "Vehicle", for
- 4 purposes of IC 13-17-5, refers to a vehicle required to be registered
- 5 with the bureau of motor vehicles and required to have brakes. The
- 6 term does not include the following:
- 7 (1) Farm tractors.
- 8 (2) Implements of husbandry.
- 9 (3) Farm tractors used in transportation.
- 10 (4) Mobile homes (house trailers).
- 11 (5) Trailers weighing not more than three thousand (3,000)
- 12 pounds.
- 13 (6) Antique motor vehicles.
- 14 (b) "Vehicle", for purposes of IC 13-18-12, means a device used to
- 15 transport a tank.
- 16 (c) "Vehicle", for purposes of IC 13-20-4, refers to a municipal
- 17 waste collection and transportation vehicle.
- 18 (d) "Vehicle", for purposes of IC 13-20-13-7, means a motor
- 19 vehicle, **farm tractor (as defined in IC 9-13-2-56(a) or**
- 20 **IC 9-13-2-56(b)), implement of husbandry (as defined in**
- 21 **IC 9-13-2-77), semitrailer (as defined in IC 9-13-2-164(a) or**
- 22 **IC 9-13-2-164(b)), and types of equipment, machinery, implements, or**
- 23 **other devices used in transportation, manufacturing, agriculture,**
- 24 **construction, or mining. The term does not include the following:**
- 25 **(+) a lawn and garden tractor that is propelled by a motor of not**

- 1 more than twenty (20) horsepower.
- 2 ~~(2) A semitrailer:~~
- 3 (e) "Vehicle", for purposes of IC 13-20-14, has the meaning set forth
- 4 in IC 9-13-2-196."
- 5 Page 3, line 8, strike "twenty-five cents (\$0.25)" and insert "**one**
- 6 **dollar (\$1)**".
- 7 Page 3, line 8, after "on" strike "the" and insert "**a**".
- 8 Page 3, line 8, delete ":" and insert "**that occurs before July 1,**
- 9 **2010:**".
- 10 Renumber all SECTIONS consecutively.
