# HOUSE MOTION \_\_\_\_\_

MR. SPEAKER:

I move that House Bill 1001 be amended to read as follows:

- 1 Page 1, delete lines 1 through 17.
- 2 Delete pages 2 through 89.
- 3 Page 90, delete lines 1 through 3.
- 4 Page 90, line 6, after "7." insert "(a)".
- 5 Page 90, between lines 19 and 20, begin a new paragraph and insert:
- 6 **"(b) This subsection applies only to an individual who qualifies**
- 7 **for a homestead credit under IC 6-1.1-20.9 against the property tax**
- 8 **liability imposed against a homestead in 2006, continues to qualify**
- 9 **for a homestead credit under IC 6-1.1-20.9 for the same homestead**
- 10 **in 2007 or 2008, or both, and is at least sixty-five (65) years of age**
- 11 **on December 31 of the year immediately preceding the year in**
- 12 **which the credit applies. A person is entitled to a credit under this**
- 13 **chapter:**
- 14 **(1) against the person's property tax liability for property**
- 15 **taxes first due and payable in 2007 and 2008 attributable to**
- 16 **the person's homestead located in the county; and**
- 17 **(2) in the amount by which the person's property tax liability**
- 18 **attributable to the person's homestead for property taxes first**
- 19 **due and payable in the year exceeds the person's property tax**
- 20 **liability for the same homestead for property taxes first due**
- 21 **and payable in 2006."**
- 22 Page 90, line 22, after "8." insert "(a)".
- 23 Page 90, line 23, after "under" insert "section 7(a) of this chapter
- 24 **and, if the person is eligible for a deduction under IC 6-1.1-12-9, a**
- 25 **credit under section 7(b) of"**.

- 1 Page 90, between lines 27 and 28, begin a new paragraph and insert:
- 2 **(b) If a person is eligible for a credit under section 7(b) of this**
- 3 **chapter but is not eligible for a deduction under IC 6-1.1-12-9, the**
- 4 **person must file an application for the credit on the form**
- 5 **prescribed by the department of local government finance with the**
- 6 **county auditor before September 1 of the year immediately**
- 7 **preceding the first year in which the credit applies. The application**
- 8 **must demonstrate in the manner determined by the department of**
- 9 **local government finance that the applicant qualifies for the credit**
- 10 **under section 7(b) of this chapter. The county auditor shall grant**
- 11 **a credit to each qualifying applicant.**
- 12 **(c) If a homestead is eligible for a credit both under both section**
- 13 **7(a) and 7(b) of this chapter, the credit under section 7(b) of this**
- 14 **chapter shall be applied first before determining the amount of the**
- 15 **credit for which the homestead is eligible under section 7(a) of this**
- 16 **chapter."**
- 17 Page 91, delete lines 32 through 42.
- 18 Delete pages 92 through 260.
- 19 Page 261, delete lines 1 through 20.
- 20 Renumber all SECTIONS consecutively.
