MR. SPEAKER:

I move that House Bill 1008 be amended to read as follows:

- 1 Page 5, between lines 29 and 30, begin a new line block indented
- 2 and insert:
- 3 **"(1) funding training programs to develop the necessary**
- 4 **workforce in Indiana to implement the entire range of**
- 5 **projects contemplated under this chapter, IC 8-15-2,**
- 6 **IC 8-15-3, IC 8-15.5, and IC 8-15.7;"**
- 7 Page 5, line 30, delete "(1)" and insert "(2)".
- 8 Page 5, line 30, delete "IC 8-15.7 or IC 8-15-3;" and insert
- 9 **"IC 8-15.7, IC 8-15-3, or IC 8-15.5-14;"**
- 10 Page 5, line 31, delete "(2)" and insert "(3)".
- 11 Page 5, line 33, delete "(3)" and insert "(4)".
- 12 Page 6, lines 39, after "distribute" insert **"the following"**.
- 13 Page 6, line 39, delete "fund fifty" and insert **"fund:**
- 14 **(1) Fifty"**.
- 15 Page 6, line 42, delete "Notwithstanding IC 8-14-1, the auditor".
- 16 Page 6, after line 42, begin a new line block indented and insert:
- 17 **"(2) The following amounts to the treasurer of state in each**
- 18 **state fiscal year beginning after June 30, 2006:**
- 19 **(A) One million dollars (\$1,000,000) for use by the**
- 20 **department of workforce development for the purposes of**
- 21 **the Indiana plan.**
- 22 **(B) The greater of:**
- 23 **(i) three hundred percent (300%) of the amount**
- 24 **expended by the department of workforce development**
- 25 **in the building trade grants program in the immediately**

1 preceding state fiscal year; or
 2 (ii) five million three hundred thousand dollars
 3 (\$5,300,000);
 4 for use by the department of workforce development for
 5 the purposes of the building trades grant program.

6 Money distributed under subdivision (2) is annually appropriated
 7 for the purposes of the distribution. Money distributed under
 8 subdivision (2) shall be treated as supplemental to all other money
 9 available for the Indiana plan and the building trades grant
 10 program and may not be the basis for reducing funding from other
 11 sources. The unencumbered balance of an amount distributed
 12 under subdivision (2) at the end of a state fiscal year does not revert
 13 to the state general fund for any other purpose and remains
 14 available for the purposes of the distribution in subsequent state
 15 fiscal years. Notwithstanding IC 8-14-1, the auditor".

16 Page 74, between lines 18 and 19, begin a new paragraph and insert:
 17 "SECTION 39. IC 22-4.1-17 IS ADDED TO THE INDIANA
 18 CODE AS A NEW CHAPTER TO READ AS FOLLOWS
 19 [EFFECTIVE JULY 1, 2006]:

20 Chapter 17. Major Moves Construction Fund Training
 21 Programs

22 Sec. 1. The department shall invest the money distributed under
 23 IC 8-14-14-6(b)(2) in training programs that develop the Indiana
 24 workforce that is needed to implement the entire range of projects
 25 contemplated under IC 8-14-14, IC 8-15-2, IC 8-15-3, IC 8-15.5,
 26 and IC 8-15.7.

27 Sec. 2. The department shall carry out section 1 of this chapter
 28 through the department's:

- 29 (1) Indiana plan grant program; and
 30 (2) building trades grant program.

31 Sec. 3. The department shall expedite the:

- 32 (1) admission of applicants to; and
 33 (2) delivery of training through;

34 the existing educational and training infrastructure in Indiana to
 35 insure that a sufficient number of skilled workers are readily
 36 available in Indiana to provide the workforce needed for the
 37 projects that are undertaken under IC 8-14-14, IC 8-15-2,
 38 IC 8-15-3, IC 8-15.5, and IC 8-15.7."

39 Page 78, between lines 6 and 7, begin a new paragraph and insert:

40 "SECTION 43. [EFFECTIVE UPON PASSAGE] The department
 41 of workforce development may adopt temporary rules in the
 42 manner provided by IC 4-22-2-37.1 for the adoption of emergency
 43 rules to carry out the purposes of IC 22-4.1-17, as added by this act.
 44 A temporary rule adopted under this SECTION expires on the
 45 earliest of the following:

- 46 (1) The date the temporary rule is superseded by another

- 1 **temporary rule adopted under this SECTION.**
- 2 **(2) The date the temporary rule is superseded by a rule**
- 3 **adopted under IC 4-22-2.**
- 4 **(3) December 31, 2007."**

5 Renumber all SECTIONS consecutively.
