I move that House Bill 1080 be amended to read as follows:

- 1 Page 1, between the enacting clause and line 1, begin a new
2 paragraph and insert:
3 "SECTION 1. IC 16-21-2-2, AS AMENDED BY P.L.96-2005,
4 SECTION 6, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
5 JULY 1, 2006]: Sec. 2. The state department shall license and regulate:
6 (1) hospitals;
7 (2) ambulatory outpatient surgical centers;
8 (3) birthing centers; ~~and~~
9 (4) abortion clinics; **and**
10 **(5) pregnancy counseling centers.**
11 SECTION 2. IC 16-21-2-2.5, AS ADDED BY P.L.96-2005,
12 SECTION 7, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
13 JULY 1, 2006]: Sec. 2.5. (a) The state department shall adopt rules
14 under IC 4-22-2 to do the following concerning birthing centers, ~~and~~
15 abortion clinics, **and pregnancy counseling centers:**
16 (1) Establish minimum license qualifications.
17 (2) Establish the following requirements:
18 (A) Sanitation standards.
19 (B) Staff qualifications.
20 (C) Necessary emergency equipment.
21 (D) Procedures to provide emergency care.
22 (E) Quality assurance standards.
23 (F) Infection control.
24 (3) Prescribe the operating policies, supervision, and maintenance
25 of medical records.

- 1 (4) Establish procedures for the issuance, renewal, denial, and
 2 revocation of licenses under this chapter. The rules adopted under
 3 this subsection must address the following:
 4 (A) The form and content of the license.
 5 (B) The collection of an annual license fee.
 6 (5) Prescribe the procedures and standards for inspections.
 7 (b) A person who knowingly or intentionally:
 8 (1) operates a birthing center, ~~or~~ an abortion clinic, **or a**
 9 **pregnancy counseling center** that is not licensed under this
 10 chapter; or
 11 (2) advertises the operation of a birthing center, ~~or~~ an abortion
 12 clinic, **or a pregnancy counseling center** that is not licensed
 13 under this chapter;
 14 commits a Class A misdemeanor."

7 **(b) The state department shall, not later than December 31,**
8 **2006, establish licensing procedures and requirements for the**
9 **licensure of pregnancy counseling centers as required under**
10 **IC 16-21-2-2.5, as amended by this act.**
11 **(c) A pregnancy counseling center shall, not later than July 1,**
12 **2007:**
13 **(1) obtain the license required; and**
14 **(2) meet the requirements established;**
15 **by the state department under IC 16-21-2-2.5, as amended by this**
16 **act.**
17 **(d) This SECTION expires December 31, 2007."**
18 Renumber all SECTIONS consecutively.
