MR. SPEAKER:

I move that House Bill 1042 be amended to read as follows:

- 1 Page 1, between the enacting clause and line 1, begin a new
- 2 paragraph and insert:
- 3 "SECTION 1. IC 9-16-1-8 IS ADDED TO THE INDIANA CODE
- 4 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
- 5 1, 2007]: **Sec. 8. (a) This section does not apply to a:**
- 6 (1) full service license branch contractor under section 4 of
- 7 this chapter; or
- 8 (2) partial services contractor under section 4.5 of this
- 9 chapter.
- 10 (b) The manager of a license branch shall ensure that all
- 11 employees of the license branch are trained in all duties performed
- 12 by employees of the license branch.
- 13 (c) The employees of a license branch must be required by the
- 14 manager of the license branch to the extent practicable to conduct
- 15 transactions when there are individuals waiting for service at the
- 16 license branch. This requirement includes staffing all terminals
- 17 when necessary.
- 18 SECTION 2. IC 9-16-1-9 IS ADDED TO THE INDIANA CODE
- 19 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
- 20 1, 2007]: **Sec. 9. (a) This section does not apply to a:**
- 21 (1) full service license branch contractor under section 4 of
- 22 this chapter; or
- 23 (2) partial services contractor under section 4.5 of this
- 24 chapter.

1 (b) The bureau shall institute a procedure to track the amount
2 of time that an individual waits for a transaction to begin after
3 arrival at a license branch. The procedure must track an
4 individual's wait time regardless of whether the individual waits
5 inside or outside the license branch.

6 (c) An individual who conducts a transaction under:

- 7 (1) IC 9-29-4, except IC 9-29-4-2;
- 8 (2) IC 9-29-5; or
- 9 (3) IC 9-29-15;

10 in person at a license branch and who waits for longer than thirty
11 (30) minutes for the transaction to begin is not required to pay a
12 fee for a transaction imposed under the statutes listed in
13 subdivisions (1) through (3). However, the individual is required to
14 pay any service charge, supplemental fee, or other fee required for
15 the transaction under any statute or rule not listed in subdivisions
16 (1) through (3)."

17 Page 1, line 7, delete "App."

18 Page 1, line 7, after "U.S.C." insert "App."

19 Page 2, after line 17, begin a new paragraph and insert:

20 "SECTION 4. IC 9-29-4-0.5 IS ADDED TO THE INDIANA CODE
21 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
22 1, 2007]: **Sec. 0.5. A fee imposed under this chapter (other than a
23 fee imposed under section 2 of this chapter) is subject to
24 IC 9-16-1-9(c).**

25 SECTION 5. IC 9-29-5-0.5 IS ADDED TO THE INDIANA CODE
26 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
27 1, 2007]: **Sec. 0.5. A fee imposed under this chapter is subject to
28 IC 9-16-1-9(c).**

29 SECTION 6. IC 9-29-15-0.5 IS ADDED TO THE INDIANA CODE
30 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
31 1, 2007]: **Sec. 0.5. A fee imposed under this chapter is subject to
32 IC 9-16-1-9(c).**"

33 Renumber all SECTIONS consecutively.
