MR. SPEAKER:

I move that House Bill 1116 be amended to read as follows:

- 1 Page 1, between the enacting clause and line 1, begin a new
- 2 paragraph and insert:
- 3 "SECTION 1. IC 20-26-5-31 IS ADDED TO THE INDIANA CODE
- 4 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
- 5 1, 2007]: **Sec. 31. (a) The governing body of a school corporation**
- 6 **shall adopt a policy that requires every certificated and**
- 7 **noncertificated employee to:**
- 8 (1) **successfully complete a course approved by the board in:**
- 9 (A) **cardiopulmonary resuscitation that includes a test**
- 10 **demonstration on a mannequin;**
- 11 (B) **removing a foreign body causing an obstruction in an**
- 12 **airway; and**
- 13 (C) **the Heimlich maneuver; or**
- 14 (2) **hold a valid certification in the procedures described in**
- 15 **subdivision (1) issued by:**
- 16 (A) **the American Red Cross;**
- 17 (B) **the American Heart Association; or**
- 18 (C) **a comparable organization or institution approved by**
- 19 **the board.**
- 20 (b) **A school employee is exempt from the requirements under**
- 21 **this section if the school employee has physical limitations that**
- 22 **make it impracticable for the employee to complete a course or**
- 23 **certification described in subsection (a)(1) or (a)(2)."**
- 24 Page 7, delete lines 24 through 37, begin a new paragraph and

1 insert:
2 "SECTION 5. IC 34-30-14-7 IS ADDED TO THE INDIANA CODE
3 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
4 1, 2007]: **Sec. 7. A school employee who:**
5 **(1) performs cardiopulmonary resuscitation on;**
6 **(2) performs the Heimlich maneuver on; or**
7 **(3) removes a foreign body that is obstructing an airway of;**
8 **another person in the course of employment as a school employee**
9 **is not liable in a civil action for damages resulting from an act or**
10 **omission occurring during the performance of a function under**
11 **this section unless the act or omission constitutes gross negligence**
12 **or willful and wanton misconduct.**
13 SECTION 6. [EFFECTIVE JULY 1, 2007] **(a) Notwithstanding**
14 **IC 20-26-5-31, as added by this act, a school employee who is**
15 **employed by a school corporation on June 30, 2007, is not required**
16 **to comply with the requirements of IC 20-26-5-31, as added by this**
17 **act, before July 1, 2009.**
18 **(b) This SECTION expires July 1, 2009."**
19 Renumber all SECTIONS consecutively.
