MR. SPEAKER:

I move that House Bill 1257 be amended to read as follows:

1 Page 1, between the enacting clause and line 1, begin a new
2 paragraph and insert:
3 "SECTION 1. IC 20-24-1-9, AS ADDED BY P.L.1-2005, SECTION
4 8, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1,
5 2007]: Sec. 9. "Sponsor" means, for a charter school, one (1) of the
6 following:
7 (1) A governing body.
8 (2) A state educational institution (as defined in IC 20-12-0.5-1)
9 that offers a four (4) year baccalaureate degree.
10 (3) The executive (as defined in IC 36-1-2-5) of a consolidated
11 city.
12 **(4) The executive (as defined in IC 36-1-2-5) of a second class**
13 **city, except an executive of a city having a population of more**
14 **than ninety thousand (90,000) but less than one hundred five**
15 **thousand (105,000).**
16 SECTION 2. IC 20-24-3-5.5 IS ADDED TO THE INDIANA CODE
17 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
18 1, 2007]: **Sec. 5.5. (a) This section applies only to a sponsor that is**
19 **the executive of a second class city.**
20 **(b) Before issuing a charter, the sponsor must receive the**
21 **approval of a majority of the members of the legislative body (as**
22 **defined in IC 36-1-2-9) of the second class city for the**
23 **establishment of a charter school. The sponsor may issue charters**

1 **for charter schools located within the second class city.**
2 SECTION 3. IC 20-24-3-17 IS ADDED TO THE INDIANA CODE
3 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
4 1, 2007]: **Sec. 17. (a) This section applies to charter schools**
5 **sponsored by the executive of a second class city.**
6 **(b) There may not be more than five (5) charter schools during**
7 **calendar year 2007 for each city described in subsection (a). There**
8 **may not be more than six (6) charter schools during calendar years**
9 **2008 through 2011 for each city described in subsection (a). During**
10 **each calendar year after 2011, there may not be more charter**
11 **schools than were allowed during the previous calendar year, plus**
12 **one (1)."**
13 Renumber all SECTIONS consecutively.
