HOUSE MOTION _____

MR. SPEAKER:

I move that House Bill 1835 be amended to read as follows:

- 1 Page 12, between lines 41 and 42, begin a new paragraph and insert:
- 2 "SECTION 12. IC 4-33-13-1.7 IS ADDED TO THE INDIANA
- 3 CODE AS A NEW SECTION TO READ AS FOLLOWS
- 4 [EFFECTIVE JULY 1, 2007]: **Sec. 1.7. (a) This section applies only**
- 5 **to an operating agent operating a riverboat in a historic hotel**
- 6 **district.**
- 7 **(b) This section applies to a state fiscal year beginning after**
- 8 **June 30, 2007, and ending before July 1, 2012.**
- 9 **(c) An operating agent is entitled to a daily credit against the**
- 10 **operating agent's wagering tax liability under section 1.5 of this**
- 11 **chapter. The amount of the credit allowed under this section for a**
- 12 **particular day is equal to the amount of admissions taxes remitted**
- 13 **by the operating agent for that day.**
- 14 **(d) A credit allowed under this section for a particular day must**
- 15 **be claimed by subtracting the amount of admissions taxes remitted**
- 16 **for that day from the amount of wagering taxes that must be**
- 17 **remitted for that day. The credit must be claimed by the operating**
- 18 **agent in the manner and form prescribed by the department on the**
- 19 **operating agent's tax return or returns.**
- 20 **(e) If the amount of the credit determined under this section for**
- 21 **a particular day exceeds the amount of wagering taxes remitted by**
- 22 **the operating agent for that day, the amount of the excess may be**
- 23 **carried forward to a later day."**
- 24 Page 39, between lines 20 and 21, begin a new paragraph and insert:

1 "SECTION 29. [EFFECTIVE JULY 1, 2007] **The department of**
2 **state revenue may adopt temporary rules in the manner provided**
3 **for the adoption of emergency rules under IC 4-22-2-37.1 to**
4 **implement IC 4-33-13-1.7, as added by this act. A temporary rule**
5 **adopted under this SECTION expires on the earliest of the**
6 **following:**
7 **(1) The date specified in the temporary rule.**
8 **(2) The date that another temporary rule adopted under this**
9 **SECTION or a rule adopted under IC 4-22-2 supersedes or**
10 **repeals the temporary rule.**
11 **(3) July 1, 2008."**
12 Renumber all SECTIONS consecutively.
