DIGEST OF INTRODUCED BILL

Citations Affected: IC 16-42-5-4.

Synopsis: Food establishment sanitary requirements exception. Removes an expiration date from a statute providing an exception to certain food establishment sanitary requirements for the sale of food at events benefiting certain organizations.

Effective: July 1, 2007.

SENATE BILL No. 190

A BILL FOR AN ACT to amend the Indiana Code concerning health.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 16-42-5-4, AS AMENDED BY P.L.138-2006,
2 SECTION 11, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2007]: Sec. 4. (a) An organization that is:
4 (1) organized for nonreligious or noneducational purposes;
5 (2) exempt from the state gross retail tax under
6 IC 6-2.5-5-21(b)(1)(B), IC 6-2.5-5-21(b)(1)(C), or
7 IC 6-2.5-5-21(b)(1)(D); and
8 (3) that offers food for sale to the final consumer at an event held
9 for the benefit of the organization;
10 is exempt from complying with the requirements of this chapter that
11 may be imposed upon the sale of food at that event if the events
12 conducted by the organization under this section take place for not
13 more than thirty (30) days in a calendar year.
14 (b) An organization:
15 (1) that is organized for:
16 (A) religious; or
17 (B) educational purposes in a non-public educational setting;



- 1 (2) that is exempt from the state gross retail tax under
- 2 IC 6-2.5-5-21(b)(1)(B), IC 6-2.5-5-21(b)(1)(C), or
- 3 IC 6-2.5-5-21(b)(1)(D); and
- 4 (3) that offers food for sale to the final consumer at an event held
- 5 for the benefit of the organization;
- 6 is exempt from complying with the requirements of this chapter that
- 7 may be imposed upon the sale of food at that event unless the food is
- 8 being provided in a restaurant or a cafeteria with an extensive menu of
- 9 prepared foods.
- 10 (c) A restaurant or cafeteria setting described in subsection (b) does
- 11 not include the following:
- 12 (1) A pitch in.
- 13 (2) A bake sale.
- 14 (3) A fish fry, chili supper, spaghetti supper, or similar event with
- 15 a limited menu.
- 16 (4) Food prepared by a licensed retail food establishment.
- 17 (5) A concession stand.
- 18 (6) Heating or serving precooked foods.
- 19 (7) Preparing or serving a continental breakfast such as rolls,
- 20 coffee, juice, milk, and cold cereal.
- 21 (8) Preparing or serving nonalcoholic or alcoholic beverages that
- 22 are not potentially hazardous beverages or ice.
- 23 (9) Preparing or serving packaged or unpackaged foods that are
- 24 not potentially hazardous foods, including elephant ears, funnel
- 25 cakes, cotton candy, confectionaries, baked goods, popcorn, and
- 26 chips and grinding coffee beans.
- 27 (10) Providing prepackaged food in the food's original package.
- 28 (d) This section does not prohibit an exempted organization from
- 29 waiving the exemption and applying for a license under this chapter.
- 30 (e) It is recommended that an organization that is exempt under this
- 31 section should still follow safe food handling practices.
- 32 (f) ~~This section expires January 1, 2008.~~
