## SENATE BILL No. 557

DIGEST OF SB 557 (Updated February 21, 2007 5:02 pm - DI 110)

**Citations Affected:** IC 25-9; IC 35-45; noncode.

**Synopsis:** Combative fighting. Defines "combative fighting." Provides that a person who knowingly or intentionally promotes or participates in combative fighting commits unauthorized combative fighting, a Class D felony. Requires the state boxing commission to adopt rules to define ultimate fighting, Ultimate Fighting Championships, and professional wrestling.

**Effective:** July 1, 2007.

## SENATE BILL No. 557

A BILL FOR AN ACT to amend the Indiana Code concerning criminal law and procedure.

*Be it enacted by the General Assembly of the State of Indiana:*

1 SECTION 1. IC 25-9-1-4.5 IS ADDED TO THE INDIANA CODE  
2 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY  
3 1, 2007]: **Sec. 4.5. In accordance with IC 35-45-18-1(b), the**  
4 **commission shall adopt rules under IC 4-22-2 to define ultimate**  
5 **fighting, Ultimate Fighting Championships, and professional**  
6 **wrestling.**

7 SECTION 2. IC 35-45-18 IS ADDED TO THE INDIANA CODE  
8 AS A **NEW** CHAPTER TO READ AS FOLLOWS [EFFECTIVE  
9 JULY 1, 2007]:

10 **Chapter 18. Combative Fighting**

11 **Sec. 1. (a) As used in this chapter, "combative fighting" (also**  
12 **known as "toughman fighting", "badman fighting", and "extreme**  
13 **fighting") means a match, contest, or exhibition that involves at**  
14 **least (2) contestants, with or without gloves or protective headgear,**  
15 **in which the contestants:**

- 16 (1) use their:  
17 (A) hands;

1                   **(B) feet; or**  
 2                   **(C) both hands and feet;**  
 3                   **to strike each other; and**  
 4                   **(2) compete for a financial prize or any item of pecuniary**  
 5                   **value.**  
 6                   **(b) The term does not include:**  
 7                   **(1) a boxing or sparring match regulated under IC 25-9;**  
 8                   **(2) ultimate fighting or Ultimate Fighting Championships, as**  
 9                   **defined by the state boxing commission in rules adopted under**  
 10                   **IC 25-9-1-4.5;**  
 11                   **(3) professional wrestling, as defined by the state boxing**  
 12                   **commission in rules adopted under IC 25-9-1-4.5; or**  
 13                   **(4) a match, contest, or game in which a fight breaks out**  
 14                   **among the participants as an unplanned, spontaneous event**  
 15                   **and not as an intended part of the match, contest, or game.**  
 16                   **Sec. 2. A person who knowingly or intentionally promotes or**  
 17                   **participates in combative fighting commits unlawful combative**  
 18                   **fighting, a Class D felony.**  
 19                   **SECTION 3. [EFFECTIVE JULY 1, 2007] IC 35-45-18-2, as**  
 20                   **added by this act, applies only to crimes committed after June 30,**  
 21                   **2007.**
