

# COMMITTEE REPORT

## MADAM PRESIDENT:

**The Senate Committee on Pensions and Labor, to which was referred Senate Bill No. 490, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:**

 19 **following:**  
 20 **(1) Administer and enforce this article and IC 25-4.5.**  
 21 **(2) Adopt rules under IC 4-22-2 that:**  
 22 **(A) are reasonably necessary or appropriate for the**  
 23 **administration and enforcement of this article and**  
 24 **IC 25-4.5;**  
 25 **(B) establish standards for the competent practice of**  
 26 **architecture, landscape architecture, and interior design;**  
 27 **(C) establish continuing education requirements for**  
 28 **registered architects, registered landscape architects, and**  
 29 **registered interior designers in accordance with IC 25-1-4;**  
 30 **and**  
 31 **(D) establish fees in accordance with IC 25-1-8.**  
 32 **(3) Prescribe the requirements for and form of certificates,**  
 33 **applications, and other documents that are required by this**  
 34 **article and IC 25-4.5.**  
 35 **(4) Issue, deny, suspend, and revoke certificates in accordance**  
 36 **with this article and IC 25-4.5.**  
 37 **(5) In accordance with IC 25-1-7, investigate complaints**  
 38 **concerning:**

- 1           **(A) registered architects, registered landscape architects,**  
 2           **and registered interior designers; or**  
 3           **(B) failure to comply with:**  
 4                **(i) this article or IC 25-4.5; or**  
 5                **(ii) rules adopted under this article or IC 25-4.5; and**  
 6           **when appropriate, take action under IC 25-1-11.**  
 7           **(6) Bring actions in the name of the state in an appropriate**  
 8           **circuit court in order to enforce compliance with:**  
 9                **(A) this article or IC 25-4.5; or**  
 10              **(B) rules adopted under this article or IC 25-4.5.**  
 11           **(7) Inspect the records of a registrant in accordance with rules**  
 12           **adopted by the board.**  
 13           **(8) Conduct or designate a board member or other**  
 14           **representative to:**  
 15                **(A) conduct public hearings on any matter for which a**  
 16                **hearing is required under this article or IC 25-4.5; and**  
 17                **(B) exercise all powers granted under IC 4-21.5.**  
 18           **(9) Adopt a seal containing the words "State Board of**  
 19           **Registration for Architects, Landscape Architects, and**  
 20           **Interior Designers", and through the professional licensing**  
 21           **agency's director, certify copies and authenticate all acts of**  
 22           **the board.**  
 23           **(10) In accordance with IC 25-1-6, use counsel, consultants,**  
 24           **and other persons, enter into contracts, and authorize**  
 25           **expenditures that are reasonably necessary or appropriate to**  
 26           **administer and enforce:**  
 27                **(A) this article or IC 25-4.5; or**  
 28                **(B) rules adopted under this article or IC 25-4.5.**  
 29           **(11) Maintain the board's office, files, records, and property**  
 30           **in the city of Indianapolis.**  
 31           **(12) Administer the registered architects, registered landscape**  
 32           **architects, and registered interior designers investigative fund**  
 33           **established by section 32 of this chapter.**  
 34           **(13) Exercise all other powers and perform all other duties**  
 35           **specifically conferred on the board by this article or**  
 36           **IC 25-4.5."**

- 34 Page 26, line 11, delete "board shall immediately revoke the interior  
35 designer's" and insert "**interior designer is subject to disciplinary**  
36 **sanctions under IC 25-1-11-12**".
- 37 Page 26, delete line 12.
- 38 Page 26, delete lines 16 through 23.

          (Reference is to SB 490 as introduced.)
