

COMMITTEE REPORT

The Senate Committee on Commerce, Public Policy and Interstate Cooperation, to which was referred House Bill No. 1045, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:

 14 **purposes of IC 14-21-4, has the meaning set forth in IC 14-21-4-2."**

- 37 **recommendations on engineering plans for courthouse related**
- 38 **projects.**
- 39 **(5) Provide county officials with information concerning**
- 40 **funding sources for courthouse preservation projects.**
- 41 **(6) Make an assessment concerning the importance of**
- 42 **preserving historic courthouses to the history and identity of**

- 1 **county seats and counties.**
- 2 **(7) Make an assessment of the importance of preserving**
- 3 **historic courthouses to the economic revitalization of county**
- 4 **seats and counties.**
- 5 **(8) Investigate the need for rehabilitation, restoration, and**
- 6 **maintenance of historic courthouses.**
- 7 **(9) Study the condition of historic courthouses.**
- 8 **(10) Study the needs of county officials in planning for the**
- 9 **successful restoration, rehabilitation, and maintenance of**
- 10 **historic courthouses.**
- 11 **(11) Meet at least once each quarter."**

42 **act. The report must be in an electronic format under IC 5-14-6."**
