# HOUSE MOTION \_\_\_\_\_

MR. SPEAKER:

I move that Engrossed Senate Bill 270 be amended to read as follows:

- 1 Page 1, between the enacting clause and line 1, begin a new
- 2 paragraph and insert:
- 3 "SECTION 1. IC 16-31-2-2 IS AMENDED TO READ AS
- 4 FOLLOWS [EFFECTIVE JULY 1, 2009]: Sec. 2. (a) The commission
- 5 is composed of ~~eleven (11)~~ **thirteen (13)** members. The governor shall
- 6 appoint the members for four (4) year terms as follows:
- 7 (1) One (1) must be appointed from a volunteer fire department
- 8 that provides emergency medical service.
- 9 (2) One (1) must be appointed from a full-time municipal fire or
- 10 police department that provides emergency medical service.
- 11 (3) One (1) must be a nonprofit provider of emergency ambulance
- 12 services organized on a volunteer basis other than a volunteer fire
- 13 department.
- 14 (4) One (1) must be a provider of private ambulance services.
- 15 (5) One (1) must be a state certified paramedic.
- 16 (6) One (1) must be a licensed physician who:
- 17 (A) has a primary interest, training, and experience in
- 18 emergency medical services; and
- 19 (B) is currently practicing in an emergency medical services
- 20 facility.
- 21 (7) One (1) must be a chief executive officer of a hospital that
- 22 provides emergency ambulance services.
- 23 (8) One (1) must be a registered nurse who has supervisory or
- 24 administrative responsibility in a hospital emergency department.

- 1 (9) One (1) must be a licensed physician who:
  - 2 (A) has a primary interest, training, and experience in trauma
  - 3 care; and
  - 4 (B) is practicing in a trauma facility.
- 5 (10) One (1) must be a state certified emergency medical service
- 6 technician.
- 7 (11) One (1) must be an individual who:
  - 8 (A) represents the public at large; and
  - 9 (B) is not in any way related to providing emergency medical
  - 10 services.
- 11 **(12) One (1) must be a program director (as defined in 836**
- 12 **IAC 4-2-2(12)(B)(ii) for a commission-certified advanced life**
- 13 **support training institution.**
- 14 **(13) One (1) must be the deputy executive director appointed**
- 15 **under IC 10-19-5-3 to manage the division of preparedness**
- 16 **and training of the department of homeland security or the**
- 17 **designee of the deputy executive director.**
- 18 (b) The chief executive officer of a hospital appointed under
- 19 subsection (a)(7) may designate another administrator of the hospital
- 20 to serve for the chief executive officer on the commission.
- 21 (c) Not more than ~~six (6)~~ **seven (7)** members may be from the same
- 22 political party."
- 23 Renumber all SECTIONS consecutively.
