- 3 **(50%) of the time consists of providing addiction counseling**
- 4 **services directly to clients diagnosed with a substance use**
- 5 **disorder."**
- 6 Page 14, line 22, after "change" insert "**substance use or**".
- 7 Page 15, line 32, after "change" insert "**substance use or**".
- 8 Page 16, line 40, strike "by the governor".
- 9 Page 17, line 27, after "in" insert "**clinical**".

7 a crime that has a direct bearing on the individual's ability to
8 practice competently.

9 (3) Holds a license in good standing as a:

10 (A) social worker under IC 25-23.6-5-1;

11 (B) clinical social worker under IC 25-23.6-5-2;

12 (C) marriage and family therapist under IC 25-23.6-8-1;

13 (D) mental health counselor under IC 25-23.6-8.5-1; or

14 (E) psychologist under IC 25-33-1-5.1.

15 (4) Files an initial application with the board before July 1,
16 2010.

17 (h) The board may exempt an individual from the requirements
18 under IC 25-23.6, as amended by this act, and grant the individual
19 a clinical addiction counselor license if the individual meets the
20 following requirements:

21 (1) Holds, before July 1, 2010, a bachelor's degree in a human
22 services or behavioral science discipline from an eligible
23 postsecondary educational institution.

24 (2) Holds a valid Level IV certification from the Indiana
25 Counselors Association on Alcohol and Drug Abuse or
26 certification at the Internationally Certified Advanced
27 Alcohol & Drug Counselor level from the International
28 Certification & Reciprocity Consortium.

29 (3) Furnishes satisfactory evidence to the board that the
30 individual has not been convicted in the last two (2) years of
31 a crime that has a direct bearing on the individual's ability to
32 practice competently.

33 (4) Has at least twenty-five (25) years of experience in clinical
34 addiction counseling.

35 (5) Files an initial application to the board before July 1,
36 2010."
